The successful candidate will have a Master's Degree in Social Work or related discipline and be registered with a regulatory body. The incumbent must have extensive experience with individual counselling (especially single session/solution focused/brief therapy and walk-in counselling), experience developing and facilitating group sessions (psycho-educational and therapeutic), and a working knowledge of relevant legislation (Personal Health Information and Privacy Act, Family and Children's Services Act, etc.). Preference will be given to applicants with additional Counselling certifications (e.g. Crisis Intervention, Addictions). Additional qualifications include the ability to practice independently using excellent clinical judgment and knowledge of mental health issues affecting young adults.

The ideal candidate would have lived experience as a member of an equity deserving group. Experience working in a cross-cultural setting with diverse populations such as international students and refugees, along with an awareness of, and/or training in anti-oppressive practices is preferred. The ability to work in a second language would be considered an asset.
