Dr. Todd Randall presented a summary on the Senate Budget Committee's involvement in its recommendation to Senate on the Proposed Operating Budget 2012-2013.

The development of the budget this year included the introduction of the Integrated Planning and Budgeting (IPB) process via a series of presentations by Gerry Munt to both Senate Budget Committee and Senate in Fall 2011. The aim was to have the IPB process in place for the proposed budget period (2012-2013 and beyond) but this was not possible.

The Senate Budget Committee has been engaged as a reviewer, as per its Terms of Reference, in the development of the Operating Budget.

A key constraint on a reliable multi-year budgeting process is the inability to project tuition revenue more than one year in advance.

The Senate Budget Committee considered the proposed Operating Budget for 2012-2013 at a meeting held on Wednesday, May 16<sup>th</sup>, 2012. While there may be some concern about the proximity of this review to the Senate meeting, there was consensus at the Senate Budget Committee meeting that the time given to review the proposed Budget was adequate.

Dr. Michael Pawlowski presented a PowerPoint presentation summarizing the proposed Operating Budget 2012-2013. The Chair called the question. CARRIED
