Message from the Chair

Welcome to the third annual issue of Lakehead Sociology News which is appearing later than in previous years, but I hope that you find it is worth waiting for. As seems to be fast becoming the norm, 2012 for the Department of Sociology was once again filled with changes.

While I was on sabbatical during the first half of 2012 the position of Acting Chair was very ably filled by Dr. Tony Puddephatt. Tony's position of Graduate Coordinator, meanwhile, was temporarily taken over by Dr. Chris Southcott. Both Tony and I returned to our usual duties as Chair and Graduate Coordinator on July 1. For a brief two-week period at the end of September, however, I had to be absent from campus and Dr. Jennifer Jarman stepped in to take over as Acting Chair. I would like to take this opportunity to thank my colleagues for helping out, so that everything was able to run smoothly.

Perhaps the biggest change in the Department during 2012 was the departure of Dr. Gary Genosko, who held the position of Canada Research Chair in Technoculture Studies from 2002-2012. The room which housed his Technoculture lab is now being used as much-needed office space for graduate students, and at a later date, we have aspirations of developing the space as a research methods lab.

Fortunately, we were able to keep Dr. Dalibor Mišina for a second year. Dr. Mišina is proving to be a popular instructor; he does an outstanding job of covering some of our theory courses and generally sparking student interest with his expertise in media, culture and society. As noted on the next page, the prestigious publisher Ashgate has just released his book *Shake*, *Rattle and Roll: Yugoslav Rock Music and the Poetics of Social Critique*.

In 2012, we saw three of our graduate students graduate with their M.A., and in September we brought in a great cohort of new graduate students. News about our graduate students can be found inside this issue.

Our usual speakers series, unfortunately, ran into a few snags for the 2012-13 year, and we were unable to bring in any speakers for the fall term. We are, however, proud to be able to feature some of our own faculty as speakers. In January, Dr. Dalibor Mišina gave a well-attended talk on the subject of his new book. As well, there are two talks for winter 2013 being given by Sociology faculty that are sponsored by other units in the university. First, Dr. Chris Southcott was chosen as Lakehead's Distinguished Researcher for 2011, and in January 2013, gave a talk about his research program.
