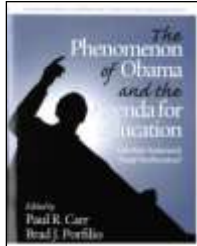
All in all, 2011 has been a great year for Sociology at Lakehead. It is a delight to be associated with such a stellar group of faculty and students.

I hope you will enjoy reading about our accomplishments in this issue!

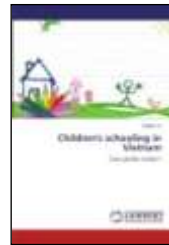

Students are working on theses and research papers on a range of fascinating topics:

- **Lisa Alaimo**, who is specializing in Women's Studies, is working on women's misrepresentation in academic science, with a focus on Marie Curie.
- **Lakhi Atwal**, who is specializing in Women's Studies, is planning to study gender differences with regard to youth incarceration, with a focus on marginalized male youth being overrepresented in correctional facilities due to charges associated with assault and aggressive behaviour.
- **Jyoti Atwal**, who is specializing in Women's Studies, is planning to study the barriers that women of colour face in the workforce.
- **Max Bernosky** is exploring the development of an Ontario-wide mandated nutrition policy. He is also working on getting a Graduate Diploma in Health Services and Policy Research.
- **Heather Cameron**, who is specializing in Women's Studies, is writing her thesis on unassisted childbirth in Canada.
- **Chris Jones** is interested in Sociology of Art as well as computer-mediated communication. He's considering putting these interests together for a research project to study the experiences of illustrators who learn or improve their technical skills through informal peer groups online.
- **Martha Lariviere** is planning to do interview-based research on the lived experience of surviving on social assistance in Ontario.

## New Faculty Profile: Dr. Jennifer Jarman

After a wonderful year as a contract faculty member, we were delighted last spring that Dr. Jennifer Jarman agreed to join us permanently. She brings a wealth of experience with her. Dr. Jarman has taught sociology on three continents. She taught for six years at the Department of Sociology at one of Asia's leading universities, the National University of Singapore, and prior to that spent ten years at the Department of Sociology and Social Anthropology, Dalhousie University, on Canada's east coast. Prior to that she was a Senior Research Associate at the University of Cambridge, where she had also completed her doctorate. She has been an executive Member of the Canadian Sociology Association and has been an editorial board member of the journals, *Capital and Class*, and the *Asian Journal of Social Sciences*.

For the past 20 years, Dr. Jarman has been involved with a program of research based at the Social and Political Sciences Department, Cambridge University under the leadership of Dr. Robert M. Blackburn. This program has been assessing the gendering of labour markets nationally and internationally, with a particular focus on segregation issues. Segregation issues have been at the core of efforts to legislate equality and develop employment policy. Findings from these projects have been published in journals including *Sociology; Work, Employment and Society*; and the *British Journal of Sociology*. The team, with the



recent addition of Dr. Girts Racko (Judge Institute of Management, Cambridge University) is currently experimenting to extend the analysis to include religious differences.

Over the past ten years, she has been working on understanding the nature of the burgeoning global call centre industry, and its implications for the careers of the people who are employed there. Although the industry has a bad reputation for exploitative and monotonous work, it has also become a major employer of university graduates around the world. Recent estimates suggest that fully 4% of the US labour force is employed in call centres, and that the volume of work the industry performs has steadily expanded with increased rationalization of service sector work processes. Dr. Jarman has conducted an analysis of the way the industry is growing in several key countries: Canada, Malaysia, Singapore and India. She is currently working on a book focusing on the

implications of her findings for regulation of the industry.

Dr. Jarman grew up in an immigrant community in Toronto, observing and discussing the impacts of globalization from an early age. She has been an avid traveller but is now one of Thunder Bay's most enthusiastic residents, looking forward to expanding her knowledge of the north shore of Lake Superior and the huge, beautiful expanse which is northwestern Ontario.
