Collaborating with the Associate Director of Clinical Programs & Services and local Indigenous Leaders, this position will serve Indigenous Children and Youth up to and including age 18 years.

As an ideal candidate you are driven by a passion for the field of children's mental health services, as well as Indigenous cultures, traditions and healing and are of Indigenous Ancestry (status blind). You possess a Bachelor or Master's Degree in a regulated profession deemed able to perform the controlled act of psychotherapy (e.g. Nursing, Occupational Therapy, Psychology, Social Work)

and current unrestricted registration with a regulatory college to perform the controlled act of psychotherapy within the province of Ontario. Your education and registration are complemented with two (2) year's of direct counselling experience applying your in-depth knowledge of appropriate mental health therapeutic approaches, interventions and clinical practices for Indigenous children and youth to address problems related to impaired functioning.

Assets include current certification in First Aid and Cardiopulmonary Resuscitation (FA/CPR), Non-violent Crisis Intervention (NCVI), Applied Suicide Intervention Skills Training (ASIST) & French Language proficiency (written and verbal).
