4.1 Senate Academic Committee Report

conditional upon the Board also approving the rescission of the Code of Student Behaviour and Disciplinary Procedures and the establishment of the Student Code of Conduct – Non-Academic Policy and the Student Code of Conduct – Appeal Policy as it related thereto. CARRIED

4.2 Senate Budget Committee Report

The Senate Budget Committee report was posted to the website in advance of the meeting.

4.2.1 Proposed University Operating Budget 2019-20 Presentation

The preliminary 2019-20 Operating Budget was posted to the website in advance of the meeting.

The Vice-President, Administration and Finance and Interim Provost and Vice-President, Academic provided a 2019/20 Budget presentation that included the following topics:

- Integrating our Planning and Budgeting at Lakehead University
- Current Context: Tuition
- Current Context: Enrolment
- Facts and Figures: Revenue
- Facts and Figures: Expenses

Considerations and Opportunities

Discussion ensued regarding the following topics:

- On page 2 of the draft Operating Budget: Whether it is proper for the phrase "(includes history)" to follow "Interdisciplinary Studies" but not mention other social sciences
- Domestic recruitment impacts, revenue and funding
- Importance of domestic recruitment in terms of SMA3 positioning and budget
- Potential discussions with Dean of Graduate Studies and other relevant Deans regarding negotiation of funding packages for graduate students
- Faculty attrition impacts on graduate student enrolment
- Predicted effects of the Ministry of Training, Colleges and Universities announcements on enrolment
- Orillia education growth vs placement availability challenges
- Rationale for increase under Miscellaneous Academic section of the Provost & Vice President (Academic) budget
- Rationale for increase in the Lakehead International budget with a request to have more detail broken down in future budget proposals
- International vs. domestic recruitment priorities
- Possible messaging to Board that, while faculty will move forward with recruitment efforts and hope mitigation strategies will be effective, from an academic perspective a zero based budget or further cuts are no longer feasible
- Risks of further cuts, including having fewer people to teach, less funds for students, and decreases in student supports, resulting in decreased enrolment and retention

It was clarified that although the draft budget presented shows a deficit, the mandate of the Board of Governors for a balanced budget has not changed and administration is working towards a balanced budget to present for Board approval in April.
