Dr. McPherson mentioned that Dr. Peggy Smith, the previous Vice-Provost, Aboriginal Initiatives posted a report entitled "Deepening our Relationships" and the report highlights our Indigenization activities.

The Vice-Provost, Aboriginal Initiatives, Ms. Denise Baxter provided information on the 100 Years of Loss exhibit being hosted at Lakehead University in April.

#### 10.4 Provost & Vice-President (Academic) Report (Dr. David Barnett)

The Provost & Vice-President (Academic) report was posted to the Lakehead University website in advance of the meeting.

Dr. Barnett highlighted the 2018-2022 Sustainability Action Plan development and encouraged Senators to provide feedback through the available avenues listed in the report.

Dr. Barnett also announced the Grand Opening of the Teaching Commons, which will be held on Thursday, April 26 at 11:30am and will feature an Interactive Open House from 1:00 to 3:00 p.m. and the Distinguished Instructor Award Lecture at 3:15 p.m.

The Acting Provost and Vice-President (Academic) noted that these topics are part of an ongoing discussion with units, Deans and the Provost's office in terms of resource allocation and strategies.

The COU Academic Colleagues report was posted to the Lakehead University website in advance of the meeting. Dr. Mallik provided a summary of the written report and emphasized the need for long term planning related to the demographic structure of the faculty (e.g. projected number of retirees, etc.)

It was clarified that the Higher Education Quality Council of Ontario (HEQCO) evaluates the postsecondary sector and provides policy recommendations to the Ministry of Advanced Education and Skills Development (MAESD) however they are not authorized to make decisions in Ontario.
