17. President's Report

The President's Report has been posted to the Senate website.

On October 24, the Presidential Task Force was created to examine policies pertaining to sexual assault prevention and to provide support to victims on campus. This Task Force will be chaired by Dr. Lori Chambers and will include students, faculty, staff and experts in sexual assault from the community to sit on the committee.

Dr. Stevenson congratulated Mrs. Rita Blais, Lakehead Universities Associate Vice-President, Financial Services, who was awarded the Council of Finance Officers – University of Ontario Distinguished Leadership Award.

Lakehead University was ranked number one for undergraduate research according to the annual ranking of Canada's Top 50 Research Universities. Lakehead University also placed second in Maclean's magazine's annual University Rankings, for undergraduate universities and ranked tenth overall.

On November 21, Lakehead's Faculty of Law received an historic approval from the Law Society of Upper Canada (LSUC) for its Integrated Practice Curriculum (IPC), the first in Canada to integrate legal professional training into a law degree.

The 2013 Teaching and Learning Week ran from November 18 to 22. The program saw a significant increase in events offered and an increase in people involved from previous years. Dr. Hanley thanked those who helped organize the event and acknowledged the work of Dr. Rhonda Koster and Dr. Moira McPherson.

In October 2012, Lakehead University submitted their Strategic Mandate Agreement (SMA) to the Ministry of Training Colleges and Universities. The Ministry is revisiting these SMA's to negotiate final agreements with all universities. On November 15, Dr. Paul Genes, Special Advisor visited Lakehead University to discuss Lakehead's SMA. The Provost's office will be working to build on its 2012 submission over the next six months.

The Provost advised Senate that the deadline for the submission is December 20, 2013. It was noted that Senators will be given ample opportunity to provide feedback in the new year.
