Dr. Rodney Hanley, Mr. Gerry Munt, and Ms. Katherine Pozihun presented a summary of the budget process. Dr. Hanley noted that this presentation addresses how Lakehead University proposes to deal with the structural deficit in a multi-year planning process. Since the province has provided a multi-year funding model, the University can now plan into the future. The budget addresses goals and objectives listed in the Strategic Plan and the Academic Plan.

Ms. Katherine Pozihun reviewed the current pressures on Lakehead University noting that the impact of recent changes had created new budget problems – pensions; reduction in student funding; provincially capped tuition rate increases; \$750 payable to the province for each foreign graduate student.

Mr. Munt noted that the increases in International student enrolment and additional revenue streams (such as ancillary Senate Meeting #5-2013 May 14, 2013 MINUTES Page 4 of 15

services) will assist in providing a balanced budget into the future.

Dr. Todd Randall reviewed the Senate Budget Committee Report.

The Chair called the question.

A Senator requested clarification on the faculty establishment information (number of tenure and tenure-track faculty) citing the LUFA Collective Agreement Article 32.01. The question relates to whether the same number of faculty members would continue into the next year. The Senator asked for the total number of faculty this year (2012-13), the previous year (2011-12) and the coming year. The Provost & Vice-President (Academic) agreed to forward this information to Senators within the next few days.

A question was raised regarding changes in the budget for administration and faculty positions over the past few years as this relates to the structural deficit. It was noted that the budgetary numbers and reductions indicated in the budget reflect the dollar amounts and provide insight into where the changes have been made both in departments and in administration.

A question was raised concerning building infrastructure to support international graduate students. The Provost & Vice-President (Academic) noted that as the growth of international students increases the funding for supports for international students will also grow.
