Business conducted at the Ogimaawin - Aboriginal Governance Council meeting held April 15, 2013:

#### Request to Serve as "Community" for Proposed Research

A doctoral student within the Faculty of Education presented a research proposal requesting that Ogimaawin will serve as her "community" for purposes of community engagement, as required in Chapter 9 of the Tri-Council Policy Statement and revised Lakehead University Research Ethics Board application documents. Ogimaawin has taken this request under advisement. The implications of the request will be examined for conflict of interest and other administrative prohibitions. Barring any, Ogimaawin will agree to the request.

#### Aboriginal Initiatives Hosts Reception for New Vice Provost-Aboriginal Initiatives

Aboriginal Initiatives held a reception for Dr. Cynthia Wesley-Esquimaux, the incoming Vice-Provost for Aboriginal Initiatives. Cynthia's will begin her duties on July 1, 2013. In the meantime, she wanted to formally introduce herself to those with whom she will be working. Many of us remember her from the notable work that she completed during an October 2011 tour of duty as a resident scholar on campus.

### Revised Smudging Policy moved forward to Office of Human Resources

Aboriginal Initiatives has been working to gather input from a variety of sources in order to update and improve the former "cultural protocol." The new policy is more practical, more specific, and provides for the offering of brief Smudging 101 workshops similar to the Pow Wow 101 workshops that have been recently held. Smudging is an important personal and social cultural practice that can be misunderstood. Aboriginal Initiatives anticipates that the revised policy and the information sessions will greatly improve the campus climate for Aboriginal cultural practice.
