## **SUBJECT:** Senate Academic Committee Report – April 2013

The Senate Academic Committee (SAC) met on March 27, 2013 and the following motions were approved and are now being recommended to Senate or to the appropriate standing subcommittees of Senate:

## 1. Masters Regulations

The SAC Regulations Subcommittee reviewed the revised Masters Regulations and reported to SAC. SAC passed a motion recommending Senate approve changes made to the Masters Regulations.

### 2. Doctoral Regulations

The SAC Regulations Subcommittee reviewed the revised Doctoral Regulations and reported to SAC. SAC passed a motion recommending that Senate approve changes made to the Doctoral Regulations.

### 3. Senate Academic Appeals Policy

A sub-committee was struck to review the current Academic Appeals Process. It is expected that the committee will complete its review by the Fall 2013.

#### 4. Senate Referrals

Referrals from the February 15, 2013 Senate meeting were sent to the appropriate standing committees.

# 5. Senate Academic Committee - Quality Assurance Subcommittee

The Department of Interdisciplinary Studies at Lakehead-Orillia is proposing an articulation agreement between Georgian College's General Arts and Science (GAAS) two (2) year diploma program and Lakehead University's Honours Bachelor of Arts and Science (HBASc) and Bachelor of Arts and Science (BASc) programs, as well as an agreement between Georgian College's Environmental Technology (Co-Op) 3-year diploma program and Lakehead University's HBASc Environmental Sustainability Major. SAC approved the completion of the first part

of both agreements. The Academic Units will continue with the completion of the second parts of the proposals (as per the Policy on Articulation Agreements). The second part details the terms of the articulation and should be developed in consultation with the Office of Admissions and Recruitment and the Registrar. The final draft of the full proposals will be submitted to the Senate Undergraduate Studies Committee and Senate Budget Committee for review and approval prior to going to Senate for approval.

# 5.1 The Cyclical Program Review of the Department of Chemistry

The Senate Academic Quality Assurance Subcommittee reviewed and approved the Final Assessment Report and Implementation Plan for the Cyclical Program Review of the Department of Chemistry. SAC approved the recommendation to accept the Final Assessment Report and Implementation Plan.
