As mentioned in Report (Part #1) to Senate meeting of May 14<sup>th</sup>, this report (Part #2) contains the recommended actions from Senate Budget Committee concerning any proposed Calendar changes that were considered at our meeting of May 10<sup>th</sup>, 2013. In addition, two Calendar entries for the two new graduate programs in the Faculty of Engineering (MSc in Mechanical Engineering and PhD in Electrical and Computer Engineering). These programs had been

previously approved at the Senate meetings of November 23, 2012 and February 15<sup>th</sup>, respectively. The final Calendar entries were to be approved once the programs had received approval from Quality Council.

Items pertaining to the January 18th, 2013 Senate Meeting

## 1. Faculty of Science and Environmental Studies

(a) Wording Change Re: PhD (Chemistry & Materials) (2013-2014) (graduate) The Senate Budget Committee recommends that Senate approve this calendar change, as there were no additional resources requested by the academic unit to offer the program under the revised academic regulations for the PhD in Chemistry & Material Science as proposed.

## 2. Faculty of Health and Behavioural Sciences

(a) Graduate Program Changes – Areas of Study (2013-2014) (graduate)
The Senate Budget Committee recommends that Senate approve this calendar change, as there were no additional resources requested by the academic unit to offer the revised program as proposed.

#### 4. Department of Interdisciplinary Studies (Orillia)

Alice den Otter attended our meeting (on May 10<sup>th</sup>) to explain the eight items referred to Senate on Feb 15<sup>th</sup>, 2013 from the Department of Interdisciplinary Studies. The first six (items 4(a) to 4(f)) are proposed Calendar changes and largely housekeeping changes. These pose no budgetary impacts. The final two items (4(g) and 4(h)) are two articulation agreements between specific programs at the Orillia campus and at Georgian College in Barrie. These kinds of pathways are being encouraged by the Province and stand to increase enrolment in programming at Orillia. These articulation agreements are not to be formally calendared, as the pathways will only be available (and thus marketed) to students in the identified programs at Georgian (i.e., General Arts and Science program and the Environmental Technology, 3-year diploma program).

## (a) Course code change - INQU to INTD (2013-2014) (undergraduate)

The Senate Budget Committee <u>recommends that Senate approve this calendar change</u>, as there were no additional resources requested by the academic unit in offering the program with these changes implemented.

# (b) HBASc Media Studies major - Admission requirements (2013-2014) (undergraduate)

The Senate Budget Committee <u>recommends that Senate approve this calendar change</u>, as there were no additional resources requested by the academic unit in offering the program with these changes implemented.

# (c) HBASc Anthropology Major - Regulations (2013-2014) (undergraduate)

## 5. Faculty of Engineering

The MSc in Mechanical Engineering and the PhD in Electrical and Computer Engineering programs had been previously approved at the Senate meetings of November 23, 2012 and February 15th, respectively. The final Calendar entries were to be approved once the programs had received approval from Quality Council. The two items below and their related motions pertain to these final Calendar entries.

(a) MSc, Mechanical Engineering (2013-2014) (graduate)
