4. SAC/O-AGC Terms of Reference

5. Student Code of Conduct – Academic Integrity Code (Code) and Appeal Policy (Policy)

The Senate Academic Committee circulated an email to all Senators on January 24, 2019 with an additional opportunity to provide feedback on the Code and Policy. Feedback was due by Tuesday, February 12, 2019 at 4pm. SAC reviewed and discussed the feedback and edits at their February 15 meeting.

The feedback received from Senators was incorporated in the final draft of the Code and Policy which were presented to SAC. The following motion was passed:

Motion: that the Senate Academic Committee endorses the new Academic Integrity Code and Appeal Policy and recommends approval by Senate.

For your convenience, both documents are attached to this report.

6. Type E course review

D Baxter and K Keiller presented a plan for creating an assessment process for Type E courses. They noted that there are various ways of incorporating the Indigenous Curriculum Requirement across programs and a one-size-fits-all approach to their review would not work well. In order to capture as many different perspectives as possible, they recommended that each Dean identify one or two faculty members who have been involved in the design, delivery and assessment of ICR courses to serve on a working group. The goal of the working group will be to identify best

practices that can be used to assess the effectiveness of current approaches to supporting the ICR.

Timing of the review was also discussed. It was proposed that a pilot, incorporating up to two courses from each Faculty, would be completed in Fall 2019. SAC supported/endorsed this approach.

7. Research Plan Consultation

C Gottardo presented the draft 2019-2024 Research Plan. A need to expand the areas of Depth was discussed, as well as a need to address knowledge transfer and a clarification on what is meant by "informatics". The Office of Research is also requesting feedback by email (vpresearch@lakeheadu.ca), in preparation for the final document.

COMPOSITION

- 3. Two members from the Senate Academic Committee, which may include a student representative
- 4. Two members from the Ogimaawin-Aboriginal Governance Council, which may include a student representative
- 5. One full-time Librarian, elected by the Librarians
- 6. Indigenous Curriculum Specialist

TERMS OF OFFICE

1, 2, 5 & 6: Ex officio

3 & 4: One-year terms (renewable)

ORGANIZATION

- 1. Chair: To be elected by the Committee
- 2. Secretary: To be elected by the Committee
- 3. Administrative Office: Office of the Provost & Vice-President (Academic)

TERMS OF REFERENCE

- 1. To include Aboriginal perspectives in relevant academic decision-making.
- 2. To identify common elements in the O-AGC Strategic Plan and the Academic Plan.
- 3. To develop a plan to facilitate and monitor implementation of the common elements in the O-AGC Strategic Plan and the Academic Plan.
- 4. To ensure that relevant items from the O-AGC are considered within further strategic and academic planning.
- 5. To review Calendar change proposals from Academic Units pertaining to the Indigenous Content Requirement and make recommendations to Senate Academic Committee.
- 6. To develop and manage the evaluation criteria including, but not limited to a set of Learner Outcomes, under the direction of Senate Academic Committee.
