

## MEMORANDUM

The Senate Organization Committee met on the morning of September 11, 2017, to review the terms of references for three Senate standing committees.

The committee postponed the motion on the Senate Research Committee pending further feedback from the committee.

The committee passed motions to recommend that Senate approves:

- The amended Senate Undergraduate Scholarships & Bursaries Committee Terms of Reference.
- The amended Senate Nominations Committee Terms of Reference.

The committee instructed the Secretariat to make some minor editorial changes to all of the Senate standing committee terms of reference to ensure consistency in formatting.

In reviewing the Senate Nominations Committee Terms of Reference the committee determined that the "Nominations to Standing Committees" policy and the "Faculty Membership on Senate Committees" policy obsolete and/or redundant, in that they are already covered in the terms of reference of the Senate Nominations committee or the Senate Bylaws. The committee therefore passed motions to recommend that the Senate rescinds the "Nominations to Standing Committees" policy and the "Faculty Membership on Senate Committee therefore passed motions to recommend that the Senate rescinds the "Nominations to Standing Committees" policy and the "Faculty Membership on Senate Committees" policy.

In addition to reviewing the amendments to the terms of reference, the committee also reviewed the timeline and process for reviewing the Senate bylaws, as the regular 5-year review is scheduled for this year. As a first step in that process, the Senate Organization Committee requests input from Senate on the bylaws as currently written, and suggestions for areas that need clarification, amendment, updating, or other improvement. This initial input is due by October 10, 2017, but there will be opportunities for feedback throughout the process. The Associate University Secretary will be sending out an email on September 19<sup>th</sup>, reminding all Senators of this opportunity, and providing links.

Outstanding work:

 Senate Research Committee Terms of Reference – POSTPONED until October meeting.

- Senate Academic Appeals Committee Review due in December 2016 (granted extension until review of the Code is completed)
- Senate Academic Committee Reviews due in January 2016 (granted extension until the newly constituted Senate Teaching & Learning Committee forms its sub-committees)
