A. CURRICULUM/CALENDAR CHANGES REFERRED FROM SENATE MEETING #1-2017 OF 23 January 2017

The Senate Undergraduate Studies Committee met on 16 March 2017 to review the following items referred from the 23 January 2017 Senate meeting:

.1 Faculty of Social Sciences and Humanities—Removing from Course Calendar (2016-SOC-6006)

The Committee recommends approval of this request.

.2 Faculty of Social Sciences and Humanities—INDI 4111 Change to Type E (2016-SOC-6007)

The Committee <u>recommends</u> approval of this request. Minor editorial changes were made to the course description and prerequisite to be consistent with Calendar language.

The Committee <u>recommends</u> approval of this request. Minor editorial changes were made to the first and second year of the program and "Native" was replaced with "Indigenous" throughout the program description.

.9 Faculty of Education—Courses-New Courses-UG-HBED-Aboriginal Education (2016-EDU-6040)

The Committee recommends approval of this request.

.10 Faculty of Education—Program-Minor Modification-Language and Course Number Changes-UG-NTEP-Aboriginal Education (2016-EDU-6042)

The Committee <u>recommends</u> approval of this request. Minor editorial changes were made to be consistent with calendar language and "Native" was replaced with "Indigenous" throughout the program description.

.11 Faculty of Education—Courses-Modifications-UG-Math Requirements for Aboriginal Education HBED (2017-EDU-6130)

The Committee <u>recommends</u> approval of this request. Minor editorial changes were made to the course descriptions for Education 2110 and 3110.

The Senate Undergraduate Studies Committee met on 30 March 2017 to review the following items referred from the 23 January 2017 Senate meeting:

.12 Faculty of Social Sciences and Humanities—Course additions and deletions Sociology (2016-SOC-6039)

The Committee <u>recommends</u> approval of this request. Editorial changes were made to the course descriptions for Sociology 3111, 3115, 2911, 2110, 3116, 3114, 3117, 4551, 4010, 4014, 4012, and 4013. Editorial changes were made to the titles for Sociology 3111, 2110, 3112, 4014, and 2555. The offering information for Sociology 3111 was corrected as well as the prerequisite for Sociology 3205.

.13 Faculty of Social Sciences and Humanities—Programs-Modifications-UG-Languages-Change to new Course Types and add Indigenous Content Requirement (2016-SOC-5879)

The Committee <u>recommends</u> approval of this request. Editorial changes were made to all programs regarding the Type A and B requirements, all letter grades were changed to number grades, and the note regarding the Indigenous Content Requirement was added. "Teaching field" was changed to "teachable" in all the concurrent Education programs to be consistent with language from the Faculty of Education.

.14 Faculty of Social Sciences and Humanities—Courses-Modification-UG-Languages-New description added to notes (2016-SOC-5906)

The Committee <u>recommends</u> approval of this request. Editorial changes were made to the notes for all courses within the request and editorial changes were made to the prerequisite and course description for French 1200.
