A. CURRICULUM/CALENDAR CHANGES REFERRED FROM SENATE MEETING #9-2016 OF 28 NOVEMBER 2016

The Senate Undergraduate Studies Committee met on 20 April 2017 to review the following items referred from the 28 November 2016 Senate meeting:

.1 Faculty of Health and Behavioural Sciences—ADMISSION Req for Kine Educ Accelerated (2016-HBS-5934)

The Committee recommends approval of this request.

.2 Faculty of Education—Certificate in Education Studies (2016-EDU-5812)

The Committee recommends approval of this request. Minor editorial changes were made to the introductory paragraph of the calendar entry.

The Senate Undergraduate Studies Committee met on 6 April 2017 to review the following items referred from the 23 January 2017 Senate meeting:

.1 Faculty of Science and Environmental Studies—Program-MajorMod-UG-Computer Science-New Specialization (2016-SCI-5980)

The Committee recommends approval of this request. Clarification was made in item (c) of the requirements to indicate that the alternative elective needs to be at the 2nd year level or higher.

.2 Faculty of Science and Environmental Studies—GEOG – Visual Arts Requirement Update (2016-SCI-5935)

The Committee recommends approval of this request. A minor editorial change was made to the requirements in the 1st year of the program.

.3 Faculty of Science and Environmental Studies—GEOG 2511 Change (2016-SCI-5966)

The Committee recommends approval of this request. A minor editorial change was made to the numbering in 2nd year of the BA Geography program. After consultation with the Chair of Undergraduate Students in Education and the Chair of Geography and the Environment, in the 1st year of the HBSc/BEd Geography P/J program it was added that students need to complete a 0.5 FCE in Music or Visual Arts.

.4 Faculty of Health and Behavioural Sciences—New Third Year Psychology Course (2017-HBS-6089)

The Committee recommends approval of this request. Minor editorial changes were made to the title, course description and prerequisite for the course.

.5 Faculty of Science and Environmental Sciences—HBASc Environmental Sustainability Major (Specialization in Ecosystem Management) (2016-SCI-6048)

The Committee recommends approval of this request.

.6 Faculty of Science and Environmental Sciences—HBASc ENSU with Specialization in Ecosystem Management – Pathway with Georgian Env Tech (2017-SCI-6150)

The Committee recommends approval of this request. The offering information and restrictive note was added to Women’s Studies 3114 and Women’s Studies 3115. Editorial changes were made to the titles for Women’s Studies 3115 and 4014.

.12 Faculty of Engineering—COURSES - MODIFICATIONS-UG-ENGINEERING - content, title and offering changes (2016-ENG-6016)

The Committee recommends approval of this request. A minor editorial change was made to the course description.

.13 Faculty of Engineering—PROGRAMS - MODIFICATIONS - UG - MECHANICAL ENGINEERING - Changes to offering hours (2017-ENG-6097)

The Committee recommends approval of this request.

.14 Faculty of Engineering—COURSES - MODIFICATIONS - UG - MECHANICAL ENGINEERING - add restriction for 4th year students (2017-ENG-6102)

The Committee recommends approval of this request.

.15 Faculty of Engineering—PROGRAMS - MODIFICATIONS - UG - ELECTRICAL ENGINEERING - addition of text for complementary studies rule (2017-ENG-6105)

The Committee recommends approval of this request.

.16 Faculty of Engineering—PROGRAMS - MODIFICATIONS - UG - ELECTRICAL LU GEORGIAN PARTNERSHIP - Changes to reflect discontinued courses (2017-ENG-6106)

The Committee recommends approval of this request. A correction was made to the title for Sociology 2755 and to the complementary studies elective note.

.17 Faculty of Engineering—PROGRAMS - MODIFICATIONS - UG - SOFTWARE ENGINEERING - addition of complementary studies rule (2017-ENG-6104)

The Committee recommends approval of this request.

.18 Faculty of Business—Structural Change to Business 1066Y (split course into Business 1056 and Business 1076) (2017-BUS-6092)

The course type classification was added to both Business 1056 and 1076 and a restrictive note indicating that students who have previous credit for Business 1066 cannot take Business 1056/1076 for credit.

.19 Faculty of Business—Structural Change to Business 1066Y (split course into Business 1056 and Business 1076) (2017-BUS-6101)

The Committee recommends approval of this request.

.20 Faculty of Business—Accounting major - CPA national accreditation standard alignment (2017-BUS-6109)

The Committee recommends approval of this request. A spelling mistake was corrected in the program requirements.

.21 Faculty of Business—Accounting major - CPA national accreditation standard alignment (2017-BUS-6110)

The Committee recommends approval of this request. For all courses within the request, minor editorial changes were made to the course descriptions, the course type classification was added, as well as the offering information.

.22 Faculty of Law—Modifications to Law courses (2017-LAW-6004)

The Committee recommends approval of this request. Minor editorial changes were made to the course descriptions for Law 2035, 2030, 2010, and 1030. Corrections were made to the course offering information for Law 2035 and 2030.
