Subject: Senate Budget Committee Report

The Senate Budget Committee met on May 3, 2018 and was short quorum by one member. Those present decided to meet with the invited Deans and conduct an electronic vote following the meeting.

- 1. The Senate Budget Committee met with Dr. Antony Gillies, Acting Dean of Engineering to discuss the following calendar changes:

Dr. Tony Gillies noted that the resources that are currently supporting Enviro will be transferred to Chemical as enviro is phased out; the proposal allows for a sustainability plan (Section 9), and table at 9.1 shows projected income, and expenses, with a new faculty hire in Year 3 of the new operation. **Following the meeting, the Committee voted electronically to recommend the above calendar changes to Senate for approval.** 

- 2. The Senate Budget Committee met with Dr. Todd Randall, Dean of Science and Environmental Studies to discuss the following calendar changes:

Dr. Todd Randall confirmed that these course and program changes reflect the change in degree nomenclature from Northern Environments and Cultures to Environmental Studies to better reflect a broad-based program. The course changes are to change the course code from, e.g., Northern Environments and Cultures 5030 to Environmental Studies 5030. Following the meeting, the Committee voted electronically to recommend the above calendar changes to Senate for approval.
