Subject: **Senate Undergraduate Studies Committee Report**

A. CURRICULUM/CALENDAR CHANGES REFERRED FROM SENATE MEETING #1-2016 OF 18 JANUARY 2016

The Senate Undergraduate Studies Committee met on 3 October 2016 to review the following item referred from the 18 January 2016 Senate meeting:

1. Faculty of Business Administration—Indigenous Content (2015-BUS-5441)

The Committee recommends approval of this request with minor editorial revisions. Offering information was added to each of the four courses in the request and editorial changes were made to the course descriptions for Business 1011, 1511, and 2038. The word "Aboriginal" in the course description for Business 2038 was changed to "Indigenous" to be consistent with language used in the other course descriptions in the request.

B. CURRICULUM/CALENDAR CHANGES REFERRED FROM SENATE MEETING #5-2016 OF 11 MAY 2016

The Senate Undergraduate Studies Committee met on 19 September 2016 to review the following items referred from the 11 May 2016 Senate meeting:

.1 Faculty of Social Sciences and Humanities—Course-New-UG-English-Honours Seminar in Ecocriticism (2016-SOC-5696)

The Committee recommends approval of this request with minor editorial revisions. The last sentence in the course description was moved to the special notes area, and a special note was added indicating that students who have previous credit in English 4914 with the topic of Ecocriticism & Environmental Theory may not take English 4017 for credit.

.2 Faculty of Social Sciences and Humanities—OUTD 4911 (2015-SOC-5698)

The Committee recommends approval of this request. Minor editorial revisions were made to the course description and the Calendar start term was changed to 2017-18.

C. CURRICULUM/CALENDAR CHANGES REFERRED FROM SENATE MEETING #7-2016 OF 19 SEPTEMBER 2016

The Senate Undergraduate Studies Committee met on 3 October 2016 to review the following item referred from the 19 September 2016 Senate meeting:

1. Faculty of Business Administration—Business Programs ICR Addition (2016-BUS-5861)

The Committee recommends approval of this request inserting a note into Business Administration program requirements outlining how the Indigenous Content Requirement will be met by completion of Business 1011, 1511, 2038, and 3017.
