Subject: Senate Undergraduate Studies Committee Report

A. CURRICULUM/CALENDAR CHANGES REFERRED FROM SENATE MEETING #7-2016 OF 19 SEPTEMBER 2016

The Senate Undergraduate Studies Committee met on 17 October 2016 to review the following item referred from the 19 September 2016 Senate meeting:

1. Faculty of Engineering--Course - Modifications - UG - Engineering - Mechanical - Addition of Prerequisites (2016-ENG-5851)

The Committee <u>recommends</u> approval of this request. A <u>minor editorial revision</u> was made to the co-requisite for Engineering 3555 in order to be consistent with Calendar language.

B. CURRICULUM/CALENDAR CHANGES REFERRED FROM SENATE MEETING #8-2016 OF 17 OCTOBER 2016

The Senate Undergraduate Studies Committee met on 31 October 2016 to review the following items referred from the 17 October 2016 Senate meeting:

.1 Faculty of Social Sciences and Humanities--Programs - UG - Political Science - Modifications to Requirements (2016-SOC-5885)

The Committee <u>recommends</u> approval of this request. Women's Studies 2317 is no longer in the Calendar and was removed from the list of recommended electives in the second year of both the BA and the HBA Political Science/Pre-Law programs. **.2 Faculty of Social Sciences and Humanities--Courses - New - UG - Political Science - Changes to Second Year Titles (2016-SOC-5886)**

The Committee recommends approval of this request.

3. Faculty of Social Sciences and Humanities--Courses - New - UG - Political Science - New Third Year Course (2016-SOC-5887)

The Committee <u>recommends</u> approval of this request. A <u>minor editorial change</u> was made to the course change and a special note was added to indicate that "Students who have already taken Political Science 3313 cannot take Political Science 3111 without the permission of the Chair of the Department of Political Science."

4. Faculty of Social Sciences and Humanities--Courses - Modifications - UG - Political Science - Change in Course Year Level (2016-SOC-5888)

The Committee <u>recommends</u> approval of this request. A <u>minor editorial change</u> was made to identify the course as an elective.

The Senate Undergraduate Studies Committee met on 21 November 2016 to review the following items referred from the 17 October 2016 Senate meeting:

.5 Faculty of Social Sciences and Humanities--New Cross Listed Courses (2016-SOC-5806)

The Committee <u>recommends</u> approval of this request. <u>Minor editorial changes</u> were made to all three courses in the request and to the course description of Indigenous Learning 2717.

.6 Faculty of Social Sciences and Humanities--Word Changes in Course Titles and Descriptions (2016-SOC-5807)

The Committee <u>recommends</u> approval of this request. <u>Minor editorial changes</u> to titles, course descriptions, and pre-requisites were made as well as the addition of offering information and Type classifications.

7. Faculty of Social Sciences and Humanities--New Cross Listed Course (2016-SOC-5808)

The Committee <u>recommends</u> approval of this request. <u>Minor editorial changes</u> were made to the course description, pre-requisite, and note, and the Type A classification was added.

8. Faculty of Social Sciences and Humanities--Amendment to Type E English Courses (2016-SOC-5803)

The Committee <u>recommends</u> approval of this request. <u>Minor editorial changes</u> were made to the pre-requisite for both courses in the request.

9. Faculty of Social Sciences and Humanities--Amendment ENGL 4012 (2016-SOC-5805)

The Committee <u>recommends</u> approval of this request. A <u>minor editorial change</u> was made to the pre-requisite to be consistent with Calendar language.

10. Faculty of Social Sciences and Humanities--Courses - Modification - UG - Languages - Change Title (2016-SOC-5819)

The Committee <u>recommends</u> approval of this request to change the course title of Italian 2510.
