## **Arising from the In Camera Session**

Responsible Investing at Lakehead University - The following statement was made by the the Chair of the Board of Governors during the open meeting:

"During the in camera portion of today's meeting, we, Lakehead University's Board of Governors, approved a motion that Lakehead University will work towards total divestment of its fossil fuel holdings by the end of the University's current Strategic Plan in 2023.

I am very proud of the Board of Governors for making this decision.

On behalf of the Board of Governors, I would like to thank our students who have shown leadership and commitment in addressing this global issue.

I would also like to thank the University's Administration for the countless hours they have spent preparing analyses and reporting to the Board on this important matter, so that the Board could make an informed decision. This was truly a collaborative effort.

This is a momentous decision. But the work to achieve this goal will take time. The process of divestment will proceed in a manner that is consistent with the Board of Governor's fiduciary and legal responsibilities. It is a complex matter, but one that we are committed to."
