# Spotlight Presentation: Enhancing the Prevention of Injury & Disability@Work: EPID@Work (Dr. Vicki Kristman)

The Board received an overview of the EPID@Work Research Institute's activities, including its recognized status as one of six research centres under the Ministry, current partnerships, and key initiatives such as the 2025 seed grant process, annual conference, and *EPID Talks*. The presentation focused on the Northwestern Ontario Workplace and Worker Health Study (NOWWHS), which explores workplace mental health and engages regional employers in long-term research. The presentation also included an update on the Indigenous Workplace Mental Health Project. Members expressed appreciation for the presentation and were impressed by the Institute's work.
