Dr. Kurissery reported that the Senate Honorary Degrees Committee has received confirmation of two of the four recipients. The President's office is continuing to work on contacting individuals to confirm the two remaining spots for the upcoming convocation ceremonies.

Dr. Stevenson noted that for next and upcoming years the Senate Honorary Degrees Committee protocol will be to report and present the honorary degree recipients at an In-camera session for Senate.

Dr. Stevenson's report was posted to the website with the Senate meeting materials.

Dr. Stevenson reported that Lakehead University has topped the applications in Ontario for Ontario Universities with a 12.6% increase that has made Lakehead the highest growth in the province. Lakehead has been analyzing the numbers and a good portion of this growth comes from new programs that have been implemented. In response to the substantial increase the admissions office is working hard and quickly to send out admissions to prospect students.

Dr. Stevenson reported on his stay in China where he visited a number of high schools and universities. In particular he mentioned the Chinese Agriculture University where he met with agents that will assist in helping Lakehead to recruit prospect students.

Dr. Stevenson also visited the Maple Leaf High School which is based on the British Columbia education curriculum. At the school was a big poster of students who are attending Canadian universities. Lakehead was noted in the number three spot and had 47 international recruitments from the Maple Leaf High School.
