Code of Student Behaviour and Disciplinary Procedures

There were three appeals filed with the Judicial Panel by students under the Code of Student Behaviour and Disciplinary Procedures (accessible on-line at <http://policies.lakeheadu.ca/policy.php?pid=60>) during the 2010-2011 academic year. One appeal was dismissed after a hearing by the Appeal Tribunal assigned to it and the other two were withdrawn by the appellants, in one case after a sanction had been altered.

Senate Academic Appeals Committee (SAAC)

During the 2010-2011 academic year two student appeal applications were filed with the SAAC under the Senate Policy Regarding Academic Appeals (accessible on-line at <http://policies.lakeheadu.ca/policy.php?pid=116>). One application was turned back because the appellant had not completed a required appeal at a lower level, and the other was dismissed at the pre-Hearing because the SAAC determined that it could not take jurisdiction in the case.
