The meeting was called to order at 2:34pm.

Mr. Neckoway led the opening prayer, followed by members and guests introducing themselves.

## 1. Approval of Agenda

The February 25, 2019 O-AGC meeting package was circulated to all members via email on February 19, 2019.

By consensus, the agenda was approved.

### 2. Declaration of Conflict of Interest

Members were reminded of their duty to declare a conflict of interest should awareness of conflict arise at any time in the meeting.

3. Approval of Previous Meeting Minutes (January 29, 2019)

The minutes of the January 29, 2019 meeting were circulated in advance with the meeting materials.

By consensus, the minutes were approved as presented.

4. Business Arising from the Minutes (not on the Agenda elsewhere)

There was no business arising from the minutes.

# 5. 2019-2024 Lakehead University Research Plan Presentation

The draft 2019-2024 Research Plan was circulated in advance with the meeting materials.

The draft Research Plan presentation was shared with the O-AGC at a Special Meeting on January 29, 2019 and a consultation session took place during the meeting. Due to time constraints, members agreed that this item would come forward at the February 25, 2019 meeting for further discussion.

It was noted that the Research Planning Committee held three additional internal consultation sessions following the session with the O-AGC on January 29.

A hardcopy synopsis of the slide presentation that was shared at the last O-AGC meeting was circulated.

Dr. Andrew P. Dean, Vice-President, Research and Innovation provided an overview of the recommendations that O-AGC members made during the consultation session and explained how some of the recommendations will be integrated into the draft Research Plan.

The final draft Plan will be posted on the Lakehead University website and the University community will have the opportunity to provide additional input. Members will be notified once the final draft of the Research Plan becomes available online. Discussion ensued.

A recommendation was made to include the traditional Land Acknowledgement in the Research Plan, noting that it appears in the Lakehead Strategic Plan and Academic Plan.

Ms. Wassegijig joined the meeting during the discussion above.

A discussion took place regarding the opportunities that O-AGC members had to provide feedback on the draft Plan following the last meeting.

Dr. Dean and Mrs. Burton left the meeting.

## 6. 2018-2023 Lakehead University Sustainability Action Plan Presentation

A presentation on the draft Lakehead University Sustainability Action Plan was shared with the O-AGC during the May 14, 2018 meeting. There have been several opportunities for members from O-AGC and throughout the Indigenous community to provide feedback on the draft Action Plan since May 14, 2018. A summary outlining the Indigenous perspectives and worldviews that have been added to the draft Action Plan was circulated in advance with the meeting materials (this summary was emailed to all members on January 31, 2019 for consideration and feedback).

Highlights from Ms. McKellar's update included:

- background information
- report on internal consultation sessions held over the last six months with members of the O-AGC, Indigenous students, members of the University's Elder's Council and with Indigenous faculty and staff
- update on the request for feedback regarding Indigenous perspectives and worldviews that have been added to the draft Action Plan

Mr. Capon joined the meeting.

Discussion ensued regarding other renewable and sustainable ideas that Ms. McKellar may want to consider in the future.

Ms. McKellar left the meeting.

The Chair provided an overview of her written report that was circulated in advance with the meeting materials.

## 8. President's Report

The President's February 2019 report to the O-AGC was circulated in advance with the meeting materials.

At the request of the Chair, the President provided an update on the Gichi Kendaasiwin Center project, reporting that she attended the budget consultation hosted by Ontario's Finance Minister Vic Fedeli on February 7, 2019 in Thunder Bay where she had the opportunity to make a case for the Gichi Kendaasiwin Centre project.

## 9. O-AGC Bylaw Review Committee Update

The Chair provided an update on the O-AGC Bylaw Review Committee's work to date in her written report (item 7), that included:

Ms. Baxter reported on the Joint SAC/O-AGC Sub-Committee's work to date regarding the delivery of the Indigenous Content Requirement (ICR) Type E Courses. She provided an overview of the draft framework being proposed and asked for feedback/comments.

There were concerns that the proposed framework may be too demanding for the faculty members involved in providing feedback on the Indigenous Content Requirement. Ms. Baxter suggested a compromise that would better suit the faculty member's schedules.

By consensus, the O-AGC supported the process proposed.

## 14. O-AGC Advisors Committee Update

Dr. Neckoway provided an update on the O-AGC Advisors Committee recent attendance and participation at meetings. He reported that the Terms of Reference of the O-AGC Advisors Committee are going to be reviewed during the O-AGC Bylaw Review.
