Ms. Bouchard led the opening prayer, followed by members and guests introducing themselves.

Dr. Barnett was invited to welcome the new Deans present at the meeting (Dr. Richards and Dr. Hughs).

The meeting was called to order at 2:04pm.

1. Approval of Agenda

The agenda was approved by consensus.

2. Declaration of Conflict of Interest

Members were reminded of their duty to declare a conflict of interest should awareness of conflict arise at any time in the meeting.

3. Approval of Previous Meeting Minutes (April 29, 2019)

The minutes of the April 29, 2019 meeting were circulated in advance with the meeting materials and were approved by consensus.

4. Business Arising from the Minutes (not on the Agenda elsewhere)

There was no business arising from the minutes.

5. Chair's Report

Ms. Bouchard provided an overview of her written report that was circulated in advance with the meeting materials. Ms. Bouchard announced Rhonda LeClair will be replacing her as the Anishinabek Employment and Training Services member on the O-AGC once Ms. Bouchard retires.

6. President's Report

The President's October report to the O-AGC was circulated in advance with the meeting materials.

Mr. Capon joined the meeting

In addition to the written report, Dr. McPherson provided a debrief of the Canada-Mexico Round Table event and the Building Reconciliation Forum that she attended.

At the request of a council member, Dr. McPherson provided an update on the Gichi Kendaasiwin project funding.

7. Consultation re Proposed Changes to the Indigenous and Aboriginal Cultural Ceremonies Policy

The proposed amendments to the Indigenous and Aboriginal Cultural Ceremonies Policy was circulated in advance with the meeting materials.

Ms. Twance provided background information and rationale for the policy coming forward at this time. She reported that the Elders have reviewed and approved the proposed amendments.

By consensus, the proposed amendments to the Indigenous and Aboriginal Cultural Ceremonies Policy were endorsed.

8. Honour Cords for Indigenous Lakehead University Graduates

Ms. Sortini joined the meeting.

Background information was circulated in advance with the meeting materials.

Dr. Barnett explained how the honour cords were used at the 2019 Convocation Ceremonies, noting that they were very well received. He provided an overview of the modifications to the cord that Administration was proposing and asked the council for their input and endorsement. Discussion ensued.

By consensus, the O-AGC endorsed the modifications proposed and the use of the Honour Cords for Indigenous Lakehead University Graduates.

9. O-AGC Bylaw Review Committee Update

Ms. Bouchard reported that the O-AGC Bylaw Review Committee held their first meeting on February 15, 2019 and has met a total of 8 times to date. The Committee conducted an analysis of best practices across Canada and is in the final stages of drafting a summary of the proposed major Bylaw amendments. A consultation session is being planned for the next O-AGC meeting.

10. Appointment(s) to the O-AGC

10.1 Election of the Chair of the O-AGC

Dr. McPherson reported that Ms. Bouchard has agreeded to remain the Chair of the O-AGC until the O-AGC Bylaw review is complete, pending approval from the council.

The Secretary made a call to the floor for nominations. No further nominations were received.

MOVED that Ms. Nancy Bouchard be elected as the Chair of the O-AGC, commencing immediately until the conclusion of the O-AGC Bylaw review or to the close of the first O-AGC meeting of the new term in the fall of 2020, whichever comes first.
