#### Memo: Academic Housing of Indigenous Languages

Dear Dr. Maundrell,

We are proposing to move the academic housing for Indigenous Language courses from the Department of Languages (in the Faculty of Social Sciences and Humanities) to the Department of Aboriginal Education (in the Faculty of Education).

This move is proposed to correct an historic anomaly by which the Department of Aboriginal Education has staffed, scheduled and maintained the calendar for the languages, while the Chair of Languages received student enquiries, Marks Management requests and Special Permissions.

The proposal will remove the necessity for two Departments to be involved in the administration of the courses and remove a source of confusion for students.

In making this proposal, we have worked with the Deputy Provost, the Chair of Languages, the Acting Chair of Aboriginal Education and the Chair of Indigenous Studies, all of whom approve the change. We have also consulted with Finance and Institutional Analysis, and there are no budget or enrolment implications.

We look forward to working with SAC to finally address this anomaly. If there are any questions, please ask.
