The President and Vice-Chancellor provided an update with respect to the continuing extensive work being completed related to the Province of Ontario's establishment of the Northern Ontario School of Medicine (NOSM) as a stand-alone post-secondary medical institution effective as of April 1, 2022.

Dr. McPherson noted that Lakehead University has been working and meeting with NOSM since January to define a future relationship and to negotiate the relevant agreements. It was noted that the discussions are progressing, and that a further update will be provided at the next Senate meeting.

Following the update, discussion ensued regarding the following topics:

- Distinction between Lakehead University's provision of health education and NOSMU's provision of medical education

Further discussion ensued regarding the potential Collaborative Doctor of Veterinary Medicine program. Dr. McPherson noted that updates on this item will be provided as the project continues to progress.
