The Senate's "Enabling Motion Graduands on Record" empowers the Dean of the Faculty and Registrar to approve late additions to the graduands' list who had not appeared on the convocation list. No motion was necessary. The list was distributed at the meeting.

- 21. Summary Report 2008-09 from Senate Undergraduate Scholarships and Bursaries Committee
 - S. Strickland summarized the Senate Undergraduate Scholarships and Bursaries Committee report.

22. President's Report

Dr. Gilbert noted that he was among 70 other representatives to meet with the Minister of Finance at a Pre-Budget Hearing on December 1st. Dr. Gilbert stressed 3 messages from universities at this time: 1) current university operating budget deficits need to be addressed; 2) pension solvency needs to be addressed; 3) government funding for infrastructure if issued to universities could stimulate the economy through long term benefits. Infrastructure funding from the government would assist Lakehead University with renovations on this campus and with new buildings on the Orillia Campus.

The COU is working toward raising political awareness of the benefits of universities to the local areas where they are located. Among the benefits emphasized are: increased volunteering; public forums; education and training opportunities; and economic spin-offs. The COU is targeting MPPs emphasizing the importance of caucus MPPs as an advocacy group on behalf of universities.

Dr. Gilbert asked for any questions related to the recent Town Hall Meeting or to this report from the President. A Senator asked if provincial capital funding were received, would it be used toward projects on the Thunder Bay Campus. Dr. Gilbert noted that there are many deferred maintenance projects that would be addressed on the Thunder Bay Campus as well as the Braun Building.

A Senator expressed concern that the process being followed in this Strategic Planning exercise is different than in the past. The Senator asked for assurance that Senators would have the opportunity for input. Dr. Gilbert noted that the draft plan, once completed, would be brought to Senate for discussion and debate. Dr. Gilbert noted that many of the members of the Strategic Plan Committee are Senators.

23. Report of the Vice-President (Academic) & Provost

- L. Hayes thanked all for a productive fall term, and acknowledged specifically those affected by the aftermath issues related to the Braun Building fire.
- L. Hayes noted that PTR hearings begin December 8th, merit balloting has been underway, and sabbatical requests will be reviewed shortly. The interviews for the Dean of Social Sciences and Humanities and the Dean of Health and Behavioural Sciences are being planned. Applications for the Dean of Graduate Studies are being accepted.

Two sets of guidelines are being developed by a subgroup of the COU Quality Assurance Transition/Implementation Task Force: one for reviews of existing undergraduate and graduate programs and the other for new program appraisals for both undergraduate and graduate programs. A draft document is expected for review and feedback to OCAV in February 2009.

The Vice-Presidents Research and the Vice-Presidents Academic in Ontario met in Toronto this week to discuss undergraduate research, Canada Research Chairs (the role and the challenges and opportunities), and Post-doctoral fellows.

- A. P. Dean is working with L. Hayes to identify student participants for a cross-disciplinary undergraduate research conference to be held in April in LaCrosse, Wisconsin.

K. Fedderson reported that the draft Orillia Strategic Plan is being reviewed and input is welcome from the faculty at the Thunder Bay Campus. The Academic Plan is part of the strategic planning process and will come to Senate for referral to committees for review.

The title transfer of the Home Farm property should be completed by late December. The transfer of this property to Lakehead University represents a significant contribution by the City of Orillia toward the Lakehead University Orillia Campus.
