

REPORT OF THE BOARD OF GOVERNORS

The Board of Governors is committed to the principle of accountability to the students, faculty and staff of Lakehead University and to the public which is served by the University. It is the intent of the Board to demonstrate this commitment by conducting its public business at meetings and then distributing the action taken.

Action Taken at November 12th Board Meeting:

- 1. At the November 12th Board Meeting, Standing Committees' 2009/10 Action Plans were approved (Audit & Risk Management, Compensation, Finance & Investment, Governance, Nominating, NOSM, Operations, Senate Liaison, and Student Liaison). The Finance and Investment Committee reviewed the Operating Budget Guidelines and recommended that the ultimate goal is to ensure that the total expenditures of the University do not exceed the anticipated revenues. 1. The President's Report consisted of the following:

Enrolment

It now appears that enrolment will be slightly above projections at both campuses. Recruiting efforts continue to ramp up for next year and part of that included a new display unit for the Ontario Universities' Fair that was well received by prospective students and their families. The free tuition for students with 95% high school averages will continue for 2010 entry.

International

Lakehead was visited by a contingent from Shenyang University in northeastern China. There appear to be strong rationales for developing a meaningful working relationship with this particular institution.

Research

Dr. Aichen Chen (Professor of Chemistry and Canada Research Chair in Material and Environmental Chemistry) won the W. Lash Miller Award from the Canadian Section of the Electrochemical Society. The award, given every two years, recognizes excellence in publications and/or technical contributions in the fields of electrochemical science and technology and/or solid state science and technology.

Dr. Robert Jickling (Education) has received the Outstanding Contributions to Research in Environmental Education Award from the North American Association for Environmental Education recognizing his commitment to environmental education research through activities that contribute to theory and practice, that report research findings, and that promote research in the area.

Dr. Rui Wang received \$750,000 (US) from the American Foundation of Asthma to study the role of hydrogen sulfide in the pathogenesis of asthma.

The 2009 joint workshop for research exchange between the University of Minnesota at Duluth (UMD) and Lakehead University was held in Duluth October 14. LU researchers visited UMDS and explored research collaboration opportunities there.

Construction

Work is progressing well on the rehabilitation of the burned out wing of the Braun Building, the sewer line from the Sanders Field House to Golf Links Road, the new telecommunications system, upgrades to classrooms and laboratories and the academic building in Orillia.

Other

The University has started training on the Customer Service Standard of the Accessibility for Ontarians with Disabilities Act. The on-line training module was developed by Queen's University and all employees will have completed training by January 2010.

Academic Program reviews are being undertaken this Fall in Mathematical Sciences and Music. Languages, Women's Studies, Psychology, Biology and Gerontology will be reviewed early next year.

The Fall Preview Day for grade 12 students was held in Orillia on November 7 and will be held in Thunder Bay on December 4.
