- 15. Update on Honorary Degree Recipients
 - J. Nicholas, Chair of the Senate Honorary Degrees Committee, reported that 3 of 4 individuals selected to receive Honorary Degrees at Lakehead University's May 2010 Convocation have confirmed.
- 16. President's Report
 - Dr. F. Gilbert reported that the Queen's Park University Day gathering was well-attended. Laurie Hayes represented Lakehead University. Dr. Gilbert noted that COU representatives met with members of the Crown to discuss issues related to post-secondary education including funding and quality education. This is a critical time to get messaging across on behalf of the universities. It is important to recognize that policies pertaining to some very sensitive items need to be addressed such as system differentiation. It is not likely that there will be capital funding available within the next few years based on the current provincial financial situation. COU is asking for funding similar to the Reaching Higher funding to accommodate the demands to meet the 40-60,000 additional students that will be entering the system mostly from the GTA. Universities cannot accommodate this increase without additional funding.
 - Dr. Gilbert announced that a Communications Bulletin will be sent out giving details on a Townhall Meeting to be held on December 17th from 10-11 am.
- 17. Report of the Vice-President (Academic) & Provost
 - L. Hayes participated in the Queen's Park University Day which provided meetings with the provincial ministers. The discussions emphasized the funding and quality issues related to post-secondary education. The discussions emphasized a request from COU for funding in a package rather than one-off funding and the necessity for funding to ensure quality. The government was thanked for the funding that has been received. L. Hayes spoke about the sustainability initiatives undertaken by Lakehead University related to energy savings and the Leed Platinum initiative at the Orillia Campus.
 - L. Hayes updated Senate on H1N1 on Lakehead's campuses. The H1N1 reported virus outbreaks seem to have peaked. An announcement was released to the university community reinstating the requirement for a doctor's note when

students are absent due to illness. Another vaccination clinic will be held on the Thunder Bay Campus on Monday.

A university preview day was held on the Thunder Bay Campus. Five hundred students from Thunder Bay and 100 students from outside the City attended. Participants received an introduction and tours of the campus were provided. The free tuition scholarship for excellence was promoted.

On December 4th the symposium on teaching and learning was held. Leesa Fawcett, from York University was the keynote speaker discussing "Teaching as if the World Mattered". Her presentation was excellent. Many additional discussions are anticipated from this symposium.

Senate recognized Dr. Syed S. Islam as the recipient of the Outstanding Teaching Award. Distinguished Instructor Award KR Jan 29 2010 He will be presenting an open lecture on "The Art of Teaching" on February 3^{rd KR Jan 29 2010} January 26th 2010.

The PTR Committees have been reviewing dossiers during the past week and will meet for deliberations.

18. Report of NOSM

Dr. Lanphear reported that the NOSM Board met over the last two days and as part of the dinner on the second day recognized outstanding students, faculty and staff. As noted last year, the Ministry has provided funding for additional students in the NOSM program. Four additional students will be accepted on each campus this upcoming year. NOSM will be working hard toward placements for students in 3rd and 4th year to accommodate the expansion.

The results of graduating students taking their licensing exam was a highlight for NOSM. They were delighted and proud of their students who ranked 6th in the country and first in the country in the clinical section which has been emphasized in the NOSM program.

19. Report of the Dean Orillia Campus

K. Fedderson reported that 53 guidance counsellors attended a breakfast event to increase the awareness of LU's presence in Simcoe County. Placements have been arranged for 250 primary/junior Education Program students. K. Fedderson thanked J. O'Meara and F. Blaikie for their assistance in ensuring all students were placed on time. The Social Work program in Orillia has expanded from 30 to 60 students since last year. Placements for these students will begin next term.

The Lakehead University Alumni Board met in Orillia for a successful event that attracted 50 to 60 LU alumni.

Celia Ross from Algoma University will be spending a half day in Orillia to learn about the Orillia satellite campus. Algoma University has a satellite campus in Brampton.

- 20. Report of the Senate Representative to the Board of Governors
 - J. Leggatt noted that the Board of Governors report is posted on the Lakehead website. At the November Board meeting, Committee action plans were approved. Finance and Investment guidelines were approved by the Board which provided up to a 4% base cut to the budget for next year. Other highlights included: the Strategic Plan 2010-2013 was approved and Student Code approved.
