17. Report of the Vice-President (Academic) & Provost

Dr. Hayes updated Senate on the activity around the Quality Assurance Framework. The COU Executive Heads will be reviewing the recommendations from the Ontario Council of Academic Vice Presidents. Three new undergraduate programs at Lakehead University are following the new framework. More detail will be coming forward to the next Senate meeting.

Dr. Hayes is continuing to solicit interest to use space at PACI. Most of the interior adjustments have been made. It is anticipated that the building will be ready for occupation by end of August.

Dr. Hayes acknowledged those who participated in the reviews for Merit. There were 62 applications. She noted that many applicants include Senate Committee as part of their service activities.

Within the next 3-4 weeks either the Aboriginal Initiatives Office or the Office of the Vice-President (Academic) will contact faculty asking about their involvement in research by, for, or with First Nations Peoples. L. Hayes will be exploring where international connections are being made in research as well. Results of both inventories will be published.

18. Report of NOSM

Dr. Lanphear reported the pivotal importance of the recently released document "The Future of Medical Education in Canada", which was funded by Health Canada. The report is the combination of a 30-month project involving extensive literature reviews, national and international consultations, and the participation of all of Canada's 17 Faculties of Medicine. The report's 10 recommendations address the growing complexities of health care in Canada and the health challenge of Canada's diverse population. Dr. Lanphear is pleased that the Northern Ontario School of Medicine has taken an approach to developing an M.D. program that is consistent with the recommendation of the study.

19. Report of the Dean Orillia Campus

K. Fedderson reported that he has been very busy working on the 2010-11 budget to accommodate increase in students in the fall. He is working on the class schedule which will include both the Heritage Place and the new academic building.

K. Fedderson noted that many new faculties will be needed as Orillia moves forward to cover over 110 FCEs. The advertising is being developed and positions will be posted soon. Search committees will be formed with representatives from both campuses.

It was noted that a discussion of particular details related to consultation on crossappointments will be continued when the search committees' templates have been developed.

20. Report of the Senate Representative to the Board of Governors

- J. Leggatt reported that the Board of Governors met on January 22nd. A report on the action taken by the Board is available through the Board website. The Board appointed members to fill vacancies on Board Committees and made some adjustments to the Board Committees' Terms of Reference as well as to the Board of Governors By-laws.
- J. Leggatt asked that her request for input as the Senate Representative on the Liaison Committee be sent again.

Kurt Dahl, who is also a member of the Board of Governors' Operations Committee, updated Senate on the construction at Orillia and renovations at PACI and the Braun Building.
