## 15. President's Report

Dr. F. Gilbert reported that Throne speeches will be presented next week at both federal and provincial levels. In the past the province had included COU in policy discussions and had promoted multi-year agreements. But recently, policies have not been shared with COU prior to their announcement and therefore, COU is not predicting what will be included in the provincial budget. Expectations are not very positive. The Federal budget commitments have been made already through the infrastructure commitments and any remaining funds likely will be put back into the general budget.

The government is indicating a large provincial budget deficit and is projecting a difficult time as it works to climb out of this situation although a local funding announcement was made today. TBRRI received over \$6M from the provincial government.

Confirmations from applicants are being received for the Orillia and Thunder Bay Campuses. Applicants listing Lakehead University as their first choice were much higher this year but the challenge will be to convert those applications into confirmations. At this time confirmations are tracking behind last year which is likely a reflection that other universities are working hard to get these students. Student growth is one way to increase revenue and many universities will use growth to combat structural deficits. There will be tremendous competition from other universities.

Dr. Gilbert noted that the student growth this past year was with discounted BIUs. A one-time grant provided relief this past year, but it is less likely that the universities will receive this funding again.

There is a very strenuous college lobbying effort underway related to the anticipated student growth in the GTA. Colleges are lobbying for the opportunity to offer 4 year degrees and to become more involved in research growth in the hopes of obtaining tri-council funding. A concerted effort is being applied to position colleges as more valuable to the province than the university sector. The university sector needs to plan its lobby effort and to reinforce the high value of universities to the province.

A Senator asked for enrolment numbers from November 2009 as reported to the province. The goal was 7200 students but he noted that 7500 would be \$3M extra in revenue. The Chair assured Senate that these numbers will be made available. L. Hayes noted that these numbers have been shared with the Deans and commented that in interpreting the funding, it is important to note that the

values reported are in various formats: head counts; full-time students; FTEs and BIUs. Funding based on enrolment is 'slip-year funding' and as such increases in funding are not realized until the following year.

## 16. Report of the Vice-President (Academic) & Provost

L. Hayes reported that this was the last day of Research and Innovation Week. The events included faculty, graduate students and undergraduate students. L. Hayes thanked those involved in all the planning and coordinating of this event and she noted that this event was very effective.

L. Hayes updated Senate on the meeting of the Vice-Presidents (Academic) (OCAV). She commented that Ontario colleges have been able to speak as one voice while universities do not speak uniformly. The result is that colleges are getting their message across about their importance while the universities are not. To counteract this imbalance, OCAV is addressing issues surrounding mobility between the two systems.

The completion of the Quality Assurance Framework was also discussed at OCAV. A draft, supported by all OCAV members, was referred to COU Executive Heads who met this week. The document was then returned to OCAV for some additional work.

The Academic Council of NOSM had a retreat to discuss the role, structure, function of the Council. Some used Lakehead University's Senate as a model in this discussion. The Council is also considering offering Professor Emeritus and Honorary Professor status. The Secretary of Senate and L. Hayes are working on refining and making the process more transparent and on defining the various appointment names which come through Senate for approval. L. Hayes will continue to report on this.

Senate discussed some of the pathways between colleges and universities that would enable student mobility between these post-secondary institutions. Degree level expectations and pathways would need to be clear.

### 18. Report of the Dean Orillia Campus

K. Fedderson thanked Senate for passing item 5.3, the HBASc in Environmental Sustainability and emphasized that this program is very important to the Orillia Campus.
