The Chair of the Senate Teaching and Learning Committee, Dr. Craig MacKinnon, reported on the evaluation of the instrument used in the Student Evaluation of Teaching Survey at Lakehead University.

17. President's Report

Dr. Brian Stevenson reviewed the President's report as posted on the Senate website. He noted that Dr. Moira McPherson would be consulting with faculty on their concerns related to wireless in the classrooms.

Dr. Brian Stevenson reported briefly on the two conferences held in conjunction with the President's Installation Ceremony. The "Role of the University In Economic Development" and the "First Nations and Postsecondary Education"

conferences were well attended and plans are underway to continue discussions with community representatives related to the presentations given at these events.

The Enrolment counts appear to be slightly above the targets at both the Thunder Bay and Orillia Campuses. The total headcount for Lakehead University will be just over 8500. The final numbers will be reported to MTCU.

The new Lakehead University branding will launch next week beginning with a media blitz. Lakehead University Posters will appear on the Toronto Transit system.

Lakehead University welcomed Ambassador Wenshen Chen, Chinese Minister-Counsellor of Education Affairs, in mid-October. Ambassador Chen toured the Thunder Bay Campus and met informally with faculty and students.

Dr. Stevenson noted that a faculty member of Senate will participate on the Associate Vice-President (International) search committee. A notice will be sent out within the next week inviting nominations from Senators.

18. Report of the Vice-President (Academic) & Provost (Acting)

Dr. Moira McPherson will be chairing the Academic Planning Committee, a subcommittee of the Senate Academic Committee. The Academic Plan will be used to connect the planning to the budget in 2012 and 4 years out.

The planning process will be divided into 4 parts:

- setting the stage which will continue through January The work will involve a SWAT analysis and an evaluation of the information;
- communication and consultation;
- synthesis of priorities and first draft, feedback and revision to be completed in the Spring 2011;
- Senate presentation and approval to be completed by December 2011.

Dr. Moira McPherson provided a Quality Assurance Framework update. The group met for the second time and reviewed the first 8 ICAP submissions. The committee is carefully reviewing the feedback to ensure consistency. It is

expected that the document will come forward to Senate in January.

The Promotion, Tenure, and Renewal (PTR) process is underway.

Dr. McPherson recently visited the Orillia Campus to assist the faculty in planning two new programs - Criminology and Media Studies. Two new graduate programs are underway at the Thunder Bay Campus.

19. Report of NOSM

Dr. William McCready reported on the Global Community Engaged Medical Education Muster. NOSM and Flinders University, Australia, jointly hosted approximately 200 participants from around the world to explore developments in Community Engaged Medical Education, Longitudinal Integrated Curricula and Socially Accountable Medical Education. This was a follow up from the ICEMEN, a conference held in Northern Ontario in 2008.

On behalf of the Northern School of Medicine, Dr. Roger Strasser accepted the 2010 Gold – Education Category award at the IPAC Deloitte Public Sector Leadership Awards Gala held in Toronto.

The NOSM bargaining unit voted 78% in favour of the proposed agreement and employees will likely return to work on November 16th. Dr. Brian Stevenson asked that everyone welcome the employees back into the campus community.

20. Report of the Dean Orillia Campus

Dr. Kim Fedderson reviewed the enrolment targets at the Orillia Campus noting that the sustainability target of 900 students for this fall likely was exceeded and that recruiting to meet the enrolment target of 1100 students for the fall of 2011 has begun. Dr. Fedderson is awaiting the funding announcement from MTCU pertaining to cutbacks in funding students enrolled in the Education program. Although this may make achieving the enrolment targets more challenging, new programs offered at the Orillia Campus will help recruit additional students.

A media blitz is planned in Southern Ontario to roll out the 2011-12 recruitment campaign.
