TA 17 - Environmental Scan of Administrative Elements and Support Programs for Canadian Armed Forces (CAF) Veterans during Military to Civilian Transition (MCT)

### 3. REQUIREMENT

3.1 Veterans Affairs Canada (VAC) requires an environmental scan to document the administrative elements<sup>1</sup> and support programs intended to optimize the mental health and well-being of Canadian Armed Forces (CAF) Veterans<sup>2</sup> during the peri-release period of Military to Civilian Transition (MCT). While VAC's focus is on the peri-release<sup>3</sup> period of MCT, documentation related to transition outside this period that is considered relevant (i.e., which may have an impact on MCT) should not be excluded. Specific requirements for the environmental scan are provided in this SOW.

## 4. BACKGROUND

4.1 VAC has launched a five-year program of research to close the knowledge gaps in understanding and supporting CAF members/Veterans undergoing MCT. The program, called *Road to Civilian Life* (R2CL), will focus on the mental health of transitioning CAF members during the *peri-release* (see definition in footnote below) MCT period. MCT is a highly individualized, multidimensional experience. There is anecdotal evidence and emerging consensus among researchers internationally that the peri-release period is particularly stressful and can have later life well-being consequences.

## 5. OBJECTIVE

5.1 The overall goal of R2CL is to enhance the mental health and well-being of CAF Veterans during MCT to facilitate an optimal transition to civilian life. The purpose of this environmental scan is to document the administrative elements and support programs intended to optimize the mental health and well-being of CAF Veterans during the perirelease period of MCT.

## 6. SCOPE

6.1 The Sub Contractor will conduct all planning, coordination and execution necessary to carry out the components of the environmental scan.

#### 7. APPLICABLE DOCUMENTS & REFERENCES

7.1 To provide additional background information, the paper "Backgrounder for the Road to Civilian Life (R2CL) Program of Research" is attached as Appendix A.

#### 8. TASKS TO BE PERFORMED

- 8.1 Consult with the VAC Scientific Authority (SA) prior to and during the environmental scan to understand the current Canadian military/Veteran context and gather information on current federal government administrative elements and programs intended to support CAF members and Veterans in the peri-release MCT period and to optimize their mental health and well-being.
- 8.2 Through discussions with staff from VAC, Department of National Defence (DND) and CAF, identify administrative elements in CAF, DND and VAC directly involved with supporting CAF members or Veterans in MCT. Upon awarding of this TA, the VAC SA will provide a list of key individuals with whom the Sub Contractor will consult (at a minimum).
- 8.3 Participate in bi-monthly teleconferences with the VAC SA to provide progress updates.
- 8.4 Examine Internet websites to identify other administrative elements and programs that provide CAF members or Veterans with support in the peri-release MCT period.
- 8.5 Conduct an environmental scan that will serve as concise resource for researchers and planners working on support services for CAF members and Veterans in the peri-release MCT period. Consideration will be given to both Regular Force and Reserve Force members/Veterans. The scan will provide the following:
  - A snapshot, point-in-time, descriptive overview of existing Canadian administrative elements and support programs intended to support CAF members and Veterans and optimize their mental health and well-being in the peri-release MCT period.
  - An overview of nationally available federal government and private or non-profit sector programs, services and supports in Canada.
  - An overview of selected provincial programs and services available province-wide to support CAF members and Veterans in MCT; for example, provincially regulated health and rehabilitation systems, public health insurance programs, etc.
  - An overview of online (Internet) services and websites that play roles in supporting CAF members and Veterans in Canada in the peri-release MCT.
  - A general comparison of the Canadian situation with the United States, Australia and the United Kingdom. The SA will provide a contact for The Technical Cooperation Panel for best practices in other countries.
- 8.8 Prepare a written report for VAC documenting the approach to the environmental scan, including the question, the methodology and the findings.
