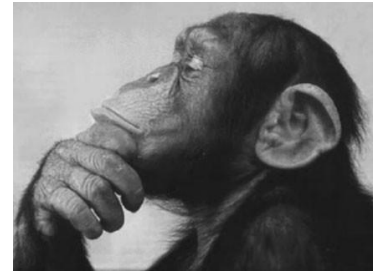

What's the purpose of this course?

This course was developed to give students an opportunity to learn more about 'hot topics' that aren't covered in depth by the core Anthropology curriculum at Lakehead University. Students are responsible for leading twice-weekly seminars on a rotating basis. This process is designed to help you develop your communication, organizational, and critical-thinking skills, as well as providing a deeper understanding of current research in anthropology. All required readings will be uploaded to myCourseLink, and students are responsible for making sure that they thoroughly read the posted articles and come to class prepared to discuss them.

Course Evaluation

Research Paper 1: 30%

- Length: 10-15 pp (double-spaced)
- Subject: Any anthropology topic of interest
- Due: **February 13** before 4:30 pm.

AutoBiography: 5%

Research Paper 2: 20%

- Length: 12-15 pp (double-spaced)

- Subject: Any anthropology topic of interest but cannot be the same as your first paper – can be on the same topic the second seminar you will lead
- **Due: Thurs., 2 before 4:30 – upload to the DropBox on MyCourseLink**

Seminars 1 and 2: 30% (total)

- for Seminar 1, you will have a pre-selected topic (if you wish); assist in selecting appropriate readings, and lead the discussion.
- for Seminar 2, you will select the topic, have it approved, select appropriate readings, and lead the discussion.

Class participation: 15%

- Grade will reflect our assessment of the extent and quality of your participation in the seminars.
- Attendance of weekly seminars is required.
