5. Proposed University Operating Budget 2014-2015

The Proposed Draft University Operating Budget 2014-2015 was posted to the Senate website.

The Acting Provost and Vice-President (Academic), Vice-President (Administration and Finance) and Associate Vice-President Financial Services presented a summary on the proposed University Operating Budget 2014-2015. The presentation addressed the structural deficit and noted that expenses are expected to grow each year. Annual cuts will be required to bring expenditures and revenues in line. The budget guidelines addressed the goals and objectives listed in the Strategic, Academic, and Operational Plans.

The Vice-President (Administration and Finance) reviewed the current pressures on Lakehead University and noted the impact of pensions, reduction in student funding, and provincially capped tuition rate increases. Replacements following resignations and retirements will continue to be strategically reviewed.

Concern was raised on the increase of International recruitment costs. The Vice-President (Administration and Finance) confirmed that the increase in International recruitment does not come from regular operating costs but rather from revenue generated through International student enrolment. Any additional costs are drawn from domestic tuition fees and provincial grants.

Concern was raised that the Faculty of Social Sciences and Humanities and the Faculty of Education had a decrease in their proposed budget. The Vice-President (Administration and Finance) noted that the decrease was due to the reductions in enrolment.
