15. Provost & Vice-President (Academic) Report

The Provost & Vice-President (Academic) Report was posted to the website.

Enrolment Update

The Provost reported that, following analysis of the Sept 28 enrolment report, data coding issues were revealed that resulted in earlier 2015/16 projections being overstated. This coding issue has now been corrected.

The enrolment numbers will remain unstable until the November 1 count date, and we will not have a full and precise picture of where we are until that data is cleaned and processed – but regardless, it is clear that we are under our projections and that this is due to a dramatic decline in Concurrent and Consecutive Education enrolments.

As many of you are probably aware the decrease in enrolment in Concurrent Education also impacts enrolment in programs offered in Social Sciences and Humanities, Science and Environmental Studies, and Health and Behavioural Sciences.

There are some positive enrolment results, both undergraduate and graduate as well as increases in the number of International students, but these will not

completely mitigate the domestic education enrolment decline.

We are addressing this as part of the budget planning for next year, and by next Senate, the day before the MTCU report due date, we will have a fuller report.

It was noted that an update on the transfer of web pages onto the new Lakehead University website system will be provided at the next Senate meeting as part of the Provost Report.

Dr. McPherson informed Senators that the development of a strategic enrolment plan has been initiated. The first phase will involve collecting data that will ultimately be used to set targets for the institution.

16. Northern Ontario School of Medicine (NOSM) Report

The NOSM Report was posted to the website. Dr. Penny Moody-Corbett noted that NOSM is currently renewing their relationship agreements.
