Senate discussed the proposed Definitions Report and the following concerns were noted:

- Not all of the Psychology Programs will be in compliance with the Definitions Report. Approving the Definition Report would require the grandfathering of many psychology programs.
- Issues were identified that would impact on Graduate programs in Psychology, particularly related to specializations or concentrations.
- Current Faculty of Business majors/minors may not meet the criteria.

In response, the consultation process was clarified. It was noted that the Definitions Ad Hoc committee reported regularly to SAC. A Notice of Motion was given at the February 2015 Senate meeting and Senators were asked to provide additional feedback. Based on feedback, additional changes were made and the report was approved by SAC in April 2015.

It was noted that this proposal is designed so that academic programs are reviewed and revised in accordance with the defintions and that the Implemenation Plan allows time (up to 2 years) for units to finalize their response. Responses can vary from arranging for full compliance to making a pedagogical argument for retaining an existing structure. It was also pointed out that the definitions only apply to undergraduate programs and that the bulk of programs already fall under, or are very close to meeting the proposed definitions.

It was suggested that additional consultation would be prudent prior to further Senate deliberation.
