OGIMAAWIN-ABORIGINAL GOVERNANCE COUNCIL (O-AGC)

The Ogimaawin- Aboriginal Governance Council met on September 2, 2014 for a special meeting and again on September 22, 2014 for its regular meeting.

September 2, 2014

Dr. B. Stevenson provided the Council with an update on serveral projects:

Kendaasiwin Centre

- The project is pending the election in spring; the Kendaasiwin Centre did not appear in budget.
- As promised the project is shovel ready and in order to proceed funding is required.
- A major lobbying campaign is required.O-AGC members were asked to obtain letters of support for the Kendaasiwin Centre. The Centre has to be seen as a priority by all northwestern Ontario aboriginal leaders.

Nanabijou Day Care

 The official opening of the new Nanabijou day care site will take place in October.

Telepresence

• On September 22nd there will be a tour of the ATAC Telepresence room.

Dr. Anne Godlewska, Professor, Queen's University and Principal Investigator for the Assessing and Addressing Awareness of First Nations, Métis and Inuit Peoples Research Project spoke to the O-AGC about the proposed research project to be conducted throughout universities in Ontario.

- Project being done to analyze Candian's education and awareness of First Nations.
- Worked with many insitutions to form and rework the survey, including Lakehead.
- Next step is to gain the support at each of the 10 universities involved.
- In January 2018 the same cohort will be surveyed again to see what the value added is from university education.
- Summary of each section of the survey was provided.

The Ogimaawin-Aboriginal Governance passed a motion to support this project in principle.

September 22, 2014

Dr. Cynthia Wesley-Esquimaux noted that a Targeted Initiatives Fund (TIF) Project Proposal application was submitted to MTCU and approved. Lakehead received the full amount of the request (\$300,000). The funds will be distributed over 2 years and will be used towards the Northwest Coordinated Learning Access Network, the Aboriginal Mentorship Programs and the On Course Workshop One initiatives.

- Northwest Coordinated Learning Access Network This initiative is designed to bring all of the local educational facilities together to provide information and opportunities to aboriginal students. The goal is to stop saying "you don't qualify" and start saying, "we will put you in touch with an educational facility that will meet your needs." Currently an invitation is being prepared for a session with various educational facilities regarding this project. A coordinator will be hired to coordinate this initiative.
- Aboriginal Mentorship Programs This Program will start with Science and ease into Engineering and then into Business.

Aboriginal Transitions Literature Review - Dr. C. Wesley Esquimaux noted that a Transitions Advisor was hired last year to connect with students and provide resources to them. It was noted that the Aboriginal Transitions Literature Review shows areas where students are having success and areas where more research is required.
