The University Librarian updated SAC on the status of the Access Copyright License (to expire August 31, 2016). A Copyright Working Group has been formed (<u>Terms of Reference</u>). In discussion about the definition of what is fair copying – the Copyright Act includes "education" as a fair dealing exception. A guideline for fair dealing is less than 10 percent. Faculty are encouraged to work with the Bookstore and Librarians with any questions regarding Course Packs and Copyright clearance workflow.
