### Georgian College-Lakehead University Submit Letter of Intent to MTCU

On June 26, a letter of intent regarding an innovative plan by the Georgian University Partnership Centre and Lakehead University to create expanded university studies in Central Ontario was submitted to the Ontario Ministry of Training, Colleges and Universities (MTCU). The Plan was developed in response to a call from the MTCU to increase degree capacity in parts of Ontario with growing demand for postsecondary education. Under the Georgian-Lakehead plan, by 2030 more than 50 degree programs will be delivered to as many as 6,000 students. Many offerings will be integrated diploma-degrees, allowing students to graduate in four years and enter the workforce sooner, better prepared for their chosen careers..

#### Strategic Management Agreement Signed

On July 31, I signed Lakehead's SMA with Ontario's Ministry of Training, Colleges and Universities. Mandated by all of Ontario's post-secondary institutions, the SMAs are designed to help post-secondary institutions build on their individual strengths, avoid or limit expansion in academic areas where programs already exist, and see to it that institutions are connected to various levels of the economy. The purpose is to ensure that students can gain experience through opportunities such as co-op programs and applied research, helping them create new businesses or find highly skilled work that will benefit Ontario.





#### Board of Governors Announces my Renewal for a Second Five-Year Term

Lakehead's Board of Governors announced that my appointment as our University's President & Vice-Chancellor has been renewed for a second five-year term, beginning in August 2015. I look forward to continuing to work with members of Senate and the rest of our Lakehead community as we head into our 50th anniversary year as a University, and, eventually, begin work on a new Academic and Strategic Plan during my second term.

#### Report on Student Appeals, 2013-2014

According to Lakehead's Director of Risk Management and Access to Information, Millo Shaw, four appeals were considered by the Judicial Panel under the <u>Code of Student Behaviour and Disciplinary Procedures</u>. Two involved academic misconduct, and two non-academic misconduct. In one academic misconduct case the sanction was reduced and in the other the student withdrew the appeal. In the non-academic misconduct cases one appeal was upheld and the other was denied.

#### **Senate Academic Appeals Committee (SAAC)**

During the 2013-2014 academic year five student appeal applications were filed with the SAAC under the <u>Senate Policy Regarding Academic Appeals</u> — all but one concerning final course marks. In one case the decision being appealed was slightly varied. In three others the SAAC found that it had no jurisdiction to hear the appeal. In the fifth case the student abandoned the appeal.

#### Major Capacity Expansion Proposal

The Ministry released its Major Capacity Expansion Policy Framework on December 20, 2013 and posted a call for full proposals due September 26, 2014. On Sept. 26, Lakehead University and Georgian College submitted its proposal for major capacity expansion to the Ontario Ministry of Training, Colleges and Universities (MTCU). Successful proposals will meet the MTCU's goals for increased capacity at the undergraduate degree level; greater affordability for students, institutions, and the province; improved institutional differentiation; and regional economic benefits. MTCU has stated that that this long-term initiative will help ensure that our postsecondary education system will have the right spaces in the right places for Ontario students.

Lakehead and Georgian have joined forces to deliver a capacity expansion strategy that is at the same time innovative, cost-effective, and sustainable. In addition to minimizing duplication of programming, this collaborative model draws on shared services to lower operating expenses and uses existing capacity to reduce infrastructure investment requirements. With this approach, the Lakehead-Georgian collaboration circumvents the need for unwarranted duplicate of infrastructure and services that already exist in the region, focuses on enhancements that fill existing gaps, and ensures a strategy that adds value to the region with its potential for innovation and economic development.


#### Lakehead University's Convocation 2014

### City of Orillia Endorses Georgian-Lakehead Expansion Plan

On July 21, Georgian College President & CEO, MaryLynn West-Moynes and I presented details of our Expansion plan to City of Orillia Special Council meeting. Our presentation explained that the Plan would see more than 50 degree programs delivered to as many as 6,000 students by 2030. Our two institutions have the capacity to add up to an additional 2,000 students, immediately, without building new infrastructure – 1,200 students at Georgian's Barrie Campus, and 800 at our Orillia campus. The Georgian/Lakehead proposal had already received the support of the County of Simcoe Council and the City of Barrie Council.
