The meeting was called to order at 2:31pm.

1. Approval of Agenda (Dr. Anita Vaillancourt)

2.	Approval of the November 1, 2021 Minutes (Dr. Anita Vaillancourt)
	The minutes of the November 21, 2021 meeting were circulated in advance with the meeting material.
	MOVED (K. Burnett) that the November 21, 2021 meeting be approved CARRIED
	The Chair welcomed and introduced a new Committee member, Céline Wick and guest Dr. Anna Guttman.
	The OIEC Advisory Committee members present introduced themselves and shared words of welcome.
3.	Planning Discussion for the Next National Day for Truth and Reconciliation (Denise Baxter and Dr. Anna Guttman)
	Highlights and common themes from the discussion included:
	<ul> <li>This topic is planned to be discussed at the Ogimaawin Indigenous Education Council meeting on January 31, 2022.</li> </ul>
	<ul> <li>Do we declare September 30th a day off at Lakehead or keep it as a regular day with classes in session?</li> </ul>
	<ul> <li>Other universities have recognized this day as a day off for staff and students to attend National Day of Truth and Reconciliation events. Last year, the Senate did not approve for the day to be recognized due to the academic calendar.</li> </ul>
	<ul> <li>Many members believe that canceling classes is important as this allows students to participate in events, however some non Indigenous students may not want to participate in such events.</li> </ul>
	<ul> <li>There is concern that if the day is declared a closure that this day may be viewed similar to Remembrance Day where the day is only viewed as a day off and the reason for the holiday is not observed. Students might not use the day for learning or reflection - we won't be able to force students to spend their time in a particular way.</li> </ul>
	<ul> <li>People have a moral obligation to attend the National Day of Truth and Reconciliation events - Instituting incentives that result in rewards or personal gains was opposed. It was recommended that "rewards" should not be offered for people participating.</li> </ul>

- A concern was raised that some faculty members would find the loss of a teaching day quite difficult.
- The University has found a way to schedule other unexpected calendar changes with a far less time allowance than the National Day of Truth and Reconciliation. The following was suggested:
  - There would be no loss of instructional days;
  - Closure on Friday Sept. 30 2022 to observe National Day of Reconciliation;
  - A makeup day for this canceled Friday would be on Tuesday Dec. 6 (currently scheduled last day of class is Dec 5);
  - Dec. 7-8 to be scheduled as study days (2 rather than 3 study days is what is provided most terms, including Fall 2021, Winter 2022 and Winter 2023;
  - o Dec 9: Exams begin as currently scheduled.
- Based on the above; Lakehead would need to consider other departments such as security, financial, etc. Although the University would be closed, maintenance staff etc are still required to work. How is a decision made on who is granted a day off to observe this day? It was suggested that Lakehead research other institutions that did declare the day off in 2021 regarding payroll issues, etc., and what worked for that particular institution.
- If the University is closed to observe the day, it may be looked upon favourably by prospective students and therefore attract a positive reaction resulting in encouraging recruitment from the north. Or it may result in retention rather than recruitment.
- Comments were also raised about staff wanting to support the community events on that day, however certain staff, particularly in the Indigenous Initiatives office don't have a choice due to having to work particular days.
- No staff or faculty would be required or expected to work on the day.
   Associated events would be held the week prior to the date.
- It is suggested that the University lean towards a "University Closure Day" rather than a "Statutory Holiday" as statutory implies that something was imposed on us which is not the case. There is also the possibility that down the road the Provincial Government may declare this day a Statutory Holiday.
- Whatever decision is made, it should be consistent throughout the University.
- It was suggested that Lakehead may want to consider June 21st National Indigenous Peoples Day, as a university closure day.

Following the discussion, the Committee decided to make a recommendation to the Ogimaawin Indigenous Education Council on January 31, 2022 regarding the National Day for Truth and Reconciliation at Lakehead. To do the timing of scheduled meetings for both the Advisors Committee and the OIEC, and to ensure that all Committee

members have the opportunity to provide feedback and vote, the Committee agreed to an electronic vote, via email, that will be conducted prior to the Ogimaawin Indigenous Education Council meeting on January 31, 2022.

Additional related comments from the "Zoom Chat" conversation included:

- "I heard from several Indigenous students that they would prefer to be in communities on this day."
- "I believe it should be considered with the same gravity as Canada Day is given. Indigenous Peoples do not deserve a holiday only if it can be afforded. Decolonization is not cheap."
- "Not sure if it's possible but if it was a stat holiday could staff donate that day's pay to a fund for Indigenous students in need."
- "I would just propose our wording has longevity for National Reconciliation day to be recognized as a holiday so it is not debated subsequently with every academic calendar year."
- "Could we as an institution send a strongly worded letter from Lakehead to the Province supporting this as a provincially recognized holiday and ask other higher education institutions to sign and join us?"

This fund is to be used for emergency purposes. There are no restrictions on this fund. It is provided to an Indigenous Student from any program in any program year. The funds are to be used for a student who would otherwise be seriously affected by their financial situation, perhaps unable to continue their studies without this bursary.
