6.	Indigenous Transition Year Program (ITYP) (Lisa Primavesi, Indigenous Access Programs Coordinator)
	An overview of the following Indigenous Access Programs was provided:
	Indigenous Transition Year Program:

	 Currently, the program is focused on: reviewing how it serves students; identifying options to credit the courses that aren't currently credited; and/or replacing these courses with electives.
	 Indigenous STEM Access Program: ITYP Coordinators are conducting a review of the program and plan to hold consultations with students, faculty, staff, funders, other community organizations, and the Advisors Committee. The group was invited to provide suggestions on how they would like to be consulted.
	Holding a consultation session with each of the academic units was suggested.
	The Committee Chair agreed that the Round Table Discussion agenda item at an upcoming meeting could be used to provide the Advisors Committee an opportunity to provide feedback.

Some topics that were raised during the discussion included:

- supporting and encouraging Indigenous student retention;
- concerning rising levels of mental health issues that Lakehead's student, faculty and staff are facing;
- the extent to which supports currently in place meet the needs of students, staff, and faculty; and
- professional development options for new and existing faculty and staff (i.e. health and wellness training) to enable them to appropriately support students in need.
