#### **Internal Updates**

- Update from the Vice-Provost, Indigenous Initiatives (Denise Baxter)
  - The Vice-Provost, Indigenous Initiatives shared some highlights from the 2024 Mexico-Canada Binational Meeting that she and two Lakehesd Indigenous students recently attended. She also mentioned that Lakehead will be hosting Indigenous students from Mexico on campus during the winter, and talked about the positive impacts this experience has on the students who were given the opportunity to participate.
  - It was reported that the Indigenous and Aboriginal Cultural Ceremonies Policy has recently been updated and is now available in the Policy Library on the Lakehead website.

## **Round Table Discussion**

- Draft Policy on Indigenous Traditional Regalia at Lakehead University's Convocation (Denise Baxter and Andrea Tarsitano)
  - Members received and reviewed the draft policy and were given the opportunity to provide feedback. Several comments were offered and suggestions were proposed that will be considered during the further development of this policy.
- Indigenous STEM Access Program Presentation and Discussion (Lisa Primavesi)
  - Members received a presentation that highlighted the history, target students, program content, and retention data for the access programs. Discussion followed.

#### **Annual Items of Business**

- SAC/OIEC Joint Subcommittee Recommendations
  - The Committee reviewed nominations received during the interest-to-serve call, and reappointed Wendy Parkes and Jessica Metcalfe to serve on the sub-committee for an additional one-year term, commencing immediately to June 30, 2025.
- SAC/OIEC Joint Sub-Committee Interest-to-Serve Nomination Form
  - The Committee reviewed the current interest-to-serve form for the SAC/OIEC Joint Sub-Committee and proposed amendments to the form. The Secretary will update the form accordingly and bring it back to the Committee for review.
