Course Description/Overview - Plants and people have been interacting since prehistoric time. In this course we shall discuss this interaction from the perspectives of history, geography, politics and economics. We shall start with man's use of plants in hunting gathering society, hydraulic society, discuss agricultural organization, talk about green revolution and modern agriculture. We shall discuss how spice trade opened up the intercontinental sea routes beginning the era of discovery, plantation agriculture, slave trade and the idea of monopoly. We shall discuss some plants of economic importance such as food, fibre, medicine, and narcotic plants in a greater detail. At the end of this course, you will have a good grasp of how plants and people have always been intimately associated with each other. Through expedition, modification, cultivation, and trade man moved plants around the world and plants useful traits in turn changed our society.
