## 1. COURSE DESCRIPTION

Habitat and plant community response to natural and human induced ecosystem disturbances will be discussed with special reference to type, intensity and frequency of disturbance. Particular attention will be focused on regeneration strategies of dominant plants, species diversity and composition, near-ground microclimate, and changes in soil physical and chemical properties. Vulnerability and resilience of ecosystem integrity will be explained on the basis of biotic and abiotic factors with special reference to boreal forests. Remediation of adverse ecological impacts resulting from human induced disturbances will be discussed. Technical writing based on field and laboratory studies, term papers, and seminar presentations are required components of the course.

## 2. COURSE GOALS

You will be introduced to key theoretical and conceptual foundations associated with disturbance ecology. Particular attention will be given to the following:

- (a) gaining an advanced understanding of the various types of disturbances and the key processes involved in initiating & propagating them;
- (b) gain knowledge of potential disturbance planning and management options;
- (c) to assess the strengths and limitations of environmental models that characterize the nature and consequences of natural and anthropogenic disturbances; and
- (d) to gain appreciation for the complexities of studying & responding to historical & novel disturbance events.

### **Analytical, technical, and applied skills**

You will:

- (a) develop a practical understanding of the challenges involved in managing of real-world cases & issues;
- (b) improve critical reading skills through evaluation and review of assigned materials;
- (c) improve written communication skills by writing short-answer responses to questions related to assigned course readings;
- (d) improve oral communication skills through in-class discussion; and
- (e) improve group environment and project management skills.

### 3. MODES OF INSTRUCTION

Assigned readings, lectures, a module, and group discussions are employed. Students are expected to be prepared in advance prior to each lecture by completing assigned readings accessible on D2L. Class time will build upon this base, focusing on important and/or more difficult concepts through lecture and discussion. During the first few weeks, lectures will generally start with an introduction to the material by me, followed by a discussion and/or question period. By week four, student groups will lead &/or assist in presenting the core concepts and ideas related to the topics covered in the assigned readings followed by structured as well as open discussion on the readings and their implications. Occasional guest speakers (two so far) will provide authoritative insight while video clips will be used regularly.

In BIOL 4115, in the context of remote instruction and participation, video and audio recordings of class activities will be made to ensure students' and instructors' easy and comprehensive access to those activities. \*\*topics to be addressed during discussion periods could include: disturbance & disease epidemics/pandemics, unexpected impacts of extreme disturbance events, warfare, climate change, social impacts of disasters, risks & impacts on the poor, etc.

**Leading discussion:** after selecting a group to be a part of (G1 to G8), your group will be responsible for *leading* the discussion in one of weeks 4 to 9. **Leading discussion involves:** reading an assigned article, creating a .ppt presentation that provides a short summary of the article for the class (5-7 min), & stimulating discussion & dialogue by asking questions & offering insight & opinions on the subject matter (23-25 min). For the remaining other weeks during discussion periods, you need to prepare for and *actively participate* in the discussion.

**Participation:** you will need to (a) read & prepare notes on the assigned article(s), (b) arrive to class with ***one (or more) questions (with answers) or critical comments*** related to the article (nb., one Q&A is required for each article scheduled for the day) – this should be printed or written out so that you have a copy ready to share with the class. A peer-reviewed reference must be included in your response (in [APA](#) formatting). Additionally, one copy with your name & student ID# should be submitted via dropbox prior to the start of discussion, and (c) actively participate.

3. Plagiarism of ideas and words as where words and an idea(s) of an author or speaker are incorporated into the body of a written assignment as though they were the writer's own words and ideas, i.e. no quotations or indentations (depending on format followed) are present and no referencing or footnoting or endnoting is given.

## *AI Policy (GenAI use)*

Generative artificial intelligence (Generative AI or GenAI) is a category of AI systems capable of generating text, images, or other media in response to prompts. These systems include ChatGPT and its variant Bing (built by OpenAI) and Bard (built by Google) among several others. Other generative AI models include artificial intelligence art systems such as Stable Diffusion, Midjourney, and DALL-E.

GenAI tools can provide valuable assistance and support in academic work. However, it is essential to use them responsibly and ethically. The following information and guidelines apply to the use of AI-based tools in this course:

- a. **Student Responsibility** – It is the responsibility of the student to understand the limitations of AI-based tools. While these tools can provide suggestions and insights, final decisions and critical thinking should come from the student's own understanding and effort. Before submitting, review your work with this in mind. If you don't understand what type of GenAI usage is appropriate, ask the course instructor for clarification.
- b. **Formative Usage** – In this class, you may use GenAI for formative, but not summative, work. That means it can be used as a “possibility engine” (brainstorm tool), a “study buddy,” a “collaboration coach,” a “guide on the side,” a “personal tutor,” a “co-designer,” etc. to help you learn course content, but it cannot be used as the primary vehicle for any work that is submitted for marks or evaluation. (See UNESCO's [“ChatGPT and Artificial Intelligence in Higher Education Quick Start Guide,”](#) page 9, for explanations and examples of these and other roles GenAI can productively serve in a formative capacity.)
- c. **Error & Bias** – AI content is created by computer algorithms that have been trained using large amounts of data. The AI learns from patterns and examples in the data to generate new content that resembles what it has been trained on. If the training data used to train the AI model is biased or limited in scope, the AI may reproduce content that is inaccurate, incomplete, offensive, and/or biased. Students should weigh this as they consider material produced by AI.
- d. **Trustworthiness** – Generative AI can be vulnerable to manipulation and misuse. It can be used to generate fake news, misinformation, or deepfake content, which can have harmful consequences. Students should check AI generated content against reputable sources.
- e. **Plagiarism** – Since [writing and critical thinking ability] are learning outcomes of this course, all work submitted for evaluation must be the student's original work. Using the work of others (including content curated/generated by AI) without proper citation is considered plagiarism. See [“Citing Artificial Intelligence”](#) for assistance with correct documentation.

- f. **Citation of Sources** – If you use material generated by an AI program for an assignment in this course, it must be cited like any other source (with due consideration for the quality of the source, which may be judged as poor). Failure to do so will be considered a violation of academic integrity. [See Student Code of Conduct – Academic Integrity.](#)
