Course Description and Learning Outcomes

Course Description COURSE DESCRIPTION

A discussion of the intersections of gender, crime, and the criminal justice system. Specific topics could include: gender correlates of crime and victimization, gendered violence, masculinity and crime, and gendered experiences within criminal justice processes.

Credit Weight: 0.5

Learning outcomes

At the end of the course students should be able to:

- 1. Explain how gender shapes our understanding of crime.
- 2. Describe how gender is central to the definitions and experiences in the criminal justice system and how it shapes victimization experiences
- 3. Identify the structures of the institutions of the criminal justice system and the experiences of workers within the system.
- 4. Critically analyze the intersections of gender, crime and the criminal justice system, that are experienced by gendered (and race, and classed, and sexualized) actors within contexts of social inequality.

2. Term paper: (30%) Perceptions of Gender and Crime in Canada

This is a 4-part essay assignment that should be written in paragraphs based on each section and uploaded to D2 not later than July 15, 2019. The paper should be 3-4 pages long, double-spaced using Times Roman font size 12.

Part 1: Personal perceptions of gender and crime

a. Describe your views, personal perceptions or thoughts regarding gender and crime b. Explain your background or experiences that may have contributed to your views. (If you do not have any personal experience, you can refer to a movie or the media that may have contributed to your beliefs) (1/2-1 page) (5 marks)

Part 2: Cultural perceptions of gender and crime

Students are required to watch this video and explain the intersections of gender, crime and the criminal justice system; that are experienced by gendered (race, classed, and sexualized) actors within contexts of social inequality. https://www.youtube.com/watch?v=XPAG3I8P34k (1 page) (10 marks)

Part 3: Official reports on Gender and crime

Read the Canadian national report entitled: **Gender Differences in Police-reported Violent Crime in Canada, 2008**. You are required to explain the relationship between gender and crime based on the Canadian national report by identifying **5 outstanding points.** (1 page) (5 marks)

Conclusion

Having completed Part 1, 2 and 3 of this paper, <u>identify and explain 5 critical issues</u> that need to be addressed in relation to gender and crime in Canada. These issues may include, but is not limited to the need for training, sensitization, research, new policies and/ or criminal justice practices (1 page) (10 marks)

3. Final Exam: (40%) Chapter 6 plus Journal articles [The final exam will consist of objective questions including multiple choice questions]
