### **Course Description and Learning Outcomes**

This course involves a comparison of numerous criminal justice systems throughout the world. Specific focus is placed on exploring how different criminal justice systems respond to common problems, issues, and events. The course will explore various examples of criminal justice systems including policing, courts and correctional systems around the world.

After successful completion of this course, students will be able to:

- (1) Critically examine and evaluate global criminal justice responses to crime.
- (2) Develop an international perspective on policing, courts, and correctional systems.
- (3) Compare and contrast criminal justice systems between different countries.

Comment posts are responses you make to the discussion posts or other comment posts. You can respond to any discussion posted by your classmates or to comments made in response to your own discussion post. You cannot receive full points by only agreeing or disagreeing with a classmate. You need to move the discussion forward by providing your perspective. You can provide further evidence from readings when you agree to a post or offer an alternative insight when you disagree. You should post your comments by Sunday at 11:59 pm each week.

There is no minimum word length for comment posts, but they should be of a reasonable length. Comment posts are typically shorter than discussion posts.
