The Chair welcomed everyone. Dr. Sandra Wolf led the opening prayer.

Dr. Mary Lou Kelley, Holly Prince, and Tom Grinnell from the Centre for Education and Research on Aging and Health (CERAH) summarized the recently funded SSHRC project "Improving End-of-Life Care in First Nations Communities: Generating a Theory of Change to Guide Program and Policy Development".

This project is a non-traditional community-based research project on Aging and Health designed to provide community education on healthy aging and to provide researchers working with community partners to develop programs of research.

These researchers are working within communities to collect palliative care data and to develop strategies that provide communities with options for palliative care. The research is based on the community needs and the final decisions on moving forward to provide palliative care are made by the community.

Ongoing projects include: Assisting Aboriginal students in regards to academic, individual, funding, culture, and their transition to Lakehead University. This month is working with students dealing with family/relationship, lack of money, affordable housing, emergency loans, food banks, OSAP application and external bursary and awards. ACSS is very busy with one on one academic support with student in regards to essay, paper, computer technical support, tutoring referrals to Learning Assistance Centre and Math Centre, and organizing Peer Mentors schedule and students that need help. We also promoted the Lakehead University Aboriginal Student Bursary by communication bulletin, 5 class room presentation to over 100 students, mass emailed, and put posters up reminding students about deadline. ACSS conducted individual financial and budget workshops to 45 participants and provided resources and information to student to minimize their financial cost.

Elder-In- Residence – Elders are available to support students three to four times a week and hours are posted on the ACSS website. Department of Aboriginal Education Report to the AMC November 15th, 2010

Dr. John Hodson will become Chair of Aboriginal Education on March 1st, 2011. Dr Hodson is a Mohawk scholar who grew up with Anishinabe people. He is currently at Brock University. We are very excited to welcome John to Lakehead University. We are seeking final approval for me to remain acting chair until John's arrival.

Judy Flett travelled to Eabametoong (Fort Hope) on Monday November 1st to support our HBEd students in a community in crisis. This trip gave much needed encouragement to students and helped to strategize about how to work with technology that is sometimes a barrier for online course delivery, with limited bandwidth and slow speeds.

Bruce Beardy visited Native Language instructors and school officials in the Northwest during the week of November 8th (Savant Lake, Pickle Lake, and Sioux Lookout) promoting the Native Language Instructors' Program and gathering feedback on educators' needs in the region.

Bruce Beardy attended a Native Language conference in St John's Newfoundland early in November as part of promotion of our programs and professional development, and took part in Ministry of Education consultations on the new Aboriginal Languages curriculum in Toronto.

In the week of November 15th Judy Flett attended a First Nations Education Conference in British Columbia for promotion and professional development. She will meet Dr. Marie Battiste, a keynote speaker. The University of Saskatchewan is setting up an Aboriginal teachers' program and, through Dr. Battiste, asked for the sharing of resources recently. We responded by sharing course outlines and an overview of our HBEd program, and by inviting Dr. Battiste to visit us here.

Education 4416 *Aboriginal Education* instructors were invited to continue discussions begun in August, sharing successes and challenges. We had an excellent meeting on November 12th including a participant via video from Orillia. I believe we have all appreciated the chance to talk and share resources.

On December 8th Rachel Mishenene will lead a workshop at the Faculty of Education on *Embedding Aboriginal Perspectives into Instructional Practice*. Rachel teaches ED 4416 and coordinated the Urban Aboriginal Education Project which provided professional development to Lakehead District School Board teachers. She will be tailoring the workshop to the curriculum areas and needs of the instructors who RSVP.

November 2010

Aboriginal Community Liaison Officer (ACLO)

Yolanda has been on the road with the APSIP tour and has prepared a report which is attached.

Nanibojou Aboriginal Graduate Enhancement (NAGE)

The NAGE coordinator has been busy establishing connections and updating the current Aboriginal graduate student's list and data base.

Two sessions were organized; a "Meet and Greet "for current Aboriginal graduate students, the other was one was an information session on Graduate programs with Faculty of Graduate Studies for under grad students currently in 3rd and 4th year.

Joan has also been working with individual students interested in Graduate studies as well as assisting with some tutoring and mentoring.

Currently, she is planning regular meetings with Aboriginal grad students.

Presidents' local Aboriginal community visits

The following Aboriginal organizations were visited as a continuation of introducing the new President Brian Stevenson to the Aboriginal community and to discuss mutual areas of interest relating to Aboriginal education. Organizations visited were: Fort William First Nations, Nishnabe Aski Nation and Oshki Pimachi O Win. This completes the local visits. Plans are underway for regional and remote community visits over the next 6-8 months.

Métis Nation of Ontario MOU

Past Chair of the Aboriginal Management Council, Tim Pile and I met with Chris Paci, Education Director of the Métis Nation of Ontario (MNO) to discuss a MOU between the MNO and Lakehead University. A draft MOU was developed and is currently under consideration by the President's office. It is expected that the MOU will be signed before the end of December to mark the end of the year of the Métis.

Lakehead University and Royal Bank of Canada (RBC) Joint Aboriginal Outreach Initiative

To launch the this project, Phil Fontaine, former National Chief of the Assembly of First Nations (AFN), was invited to speak to St. Patrick high school students in his current capacity as Special Advisor to RBC. In his talk, he addressed RBC's long history of service to the Aboriginal community. He also presented the organization's ongoing effort to build relationships and serve Aboriginal Peoples by: improving access to financial services; providing employment, training, and development, and procurement opportunities; and contributing to community and social development.

This event launched the RBC – Lakehead University Joint Aboriginal Outreach Program, a collaborative, one-year, four-stage pilot project between Lakehead University's Office of Aboriginal Initiatives and RBC.

The program will offer a series of events and activities to Aboriginal youth living in and around Thunder Bay over the upcoming year.

Elements comprising the joint project include:

Aboriginal Discovery Day

Aboriginal students age fifteen and older will have the opportunity to visit Lakehead's Thunder Bay campus and participate in a full day of interactive discussions, presentations, and tours. The event will take place in conjunction with *Aboriginal Awareness Week* in March 2011. Aboriginal students will also have the opportunity to discuss specific Lakehead programs with faculty and support services staff so they can become more confident in making educational decisions. Information relating to the employment opportunities that exist upon graduation will also be presented.

Mentor Program

From March to November 2011, participants will be matched with both a third-year Aboriginal student and a Lakehead faculty member who will provide ongoing support and resources including regularly scheduled meetings; guidance, knowledge, advice, and feedback relative to the mentors' area(s) of expertise, and a "learning partner" with whom the mentors can discuss additional recommendations to ensure the student's continued direction and support.

Speaker Series

Participants from *Aboriginal Discovery Day* and the *ACCESS* programs, as well as more than 700 self-identified Aboriginal students at Lakehead's Thunder Bay and Orillia campuses, are able to attend two *Speaker Series* presentations in November 2011.

Wrap-Up Celebration

Also in November 2011, participants involved in *Aboriginal Discovery Day* and/or the *Mentor Program* or *Speaker Series* will be recognized at a reception that celebrates the partnerships and friendships resulting from this joint initiative. Awards will be presented to *Mentor Program* participants.

Presidents Installation

Participated and attended all of the events around the President installation ceremonies, which included the following: Chancellor's dinner, Conference on Economic Development and the role of the University featuring Phil Fontaine as guest speaker, breakfast with Lloyd Axworthy, President of University of Winnipeg, sharing his perspective on reaching out to the Aboriginal community and finally concluding with the official installation ceremony at PACI.

Manito Ahbee

The Office of Aboriginal Initiatives attended this annual cultural celebration and had an information booth set up during the three day event. The Aboriginal Peoples Choice Music Awards and Aboriginal were part of the Manito Ahbee. Two awards went to Thunder Bay's Shy Anne Harvoka for best female

artist of the year and best engineered DVD. Shy Anne is also a graduate of Lakehead University and a member of the Aboriginal Alumni. We are all so proud of her.

Ministry of Training, Colleges and Universities (MTCU)

I have been invited to take part in the MTCU Steering Committee representing Council of Universities (COU) Reference Group on Aboriginal Education Aboriginal to assist with the development of a 2011 Aboriginal Post-Secondary Education (APSE) Gathering.

The objectives of the 2011 Aboriginal PSE Gathering will be to:

- Identify and share effective practices and emerging priorities to improve First Nation, Métis and Inuit student achievement and to close the postsecondary education gap.
- Address the importance of setting meaningful performance measures and effective data collection mechanisms.
- Foster better understanding of the needs, aspirations and perspectives of Aboriginal learners and provide vehicles for enhanced collaboration.

The two-day Aboriginal Postsecondary Education Gathering will bring together key Aboriginal and non-Aboriginal faculty, practitioners, administrators, educators and learners.

Aboriginal Research Facilitator

Received 23 applications for this position. The interview committee reviewed and screened applicants down to six to interview with a couple extras as back up. Interviews will commence this Wednesday and completed by first week of December.

Aboriginal Counselor position

The position had to be re advertised as the first round did not result in suitable applicants. It is hoped that a successful applicant will be found in this second round.

Aboriginal Liaison/Recruiter Intern position

This intern position is a funded by NOHFC and supplemented by Office of Aboriginal Initiatives. It has been advertised for a second time and hope to have it filled before the end of December. The intern will assist with Aboriginal recruitment and outreach activities.

Community Education and Awareness

In a joint collaboration Northern Studies Dept and Office of Aboriginal Initiatives presented two viewings and discussion on the film 3rd World Canada. This film features eight children and their community who are left behind to piece together the aftermath of a suicide and the legacy of impoverished 3rd world conditions bound by treaty laws signed by their non English speaking ancestors. Both sessions were well attended, over 250 at each viewing.

Gichi Kendaasiwin Centre

The Kendaasiwin committee met with members of the local Aboriginal Cultural Centre project to compare project goals and objectives and to discuss how both projects could collaborate and support one another.

Native Access Program report

The Native Access Program had 15 students enrolled in September and 1 student has officially withdrawn. Two returning students are completing the Math FA (Fall section) and one will complete the Math WA (winter section). Twelve of the fourteen current students are band sponsored and monthly reports have been sent to Education Authorities/Counsellors. These are to report on attendance and progress. On-going communication with Education counsellors is key to student support and success. The instructors meeting took place on October 27.

Some students are facing personal and medical situations and are dealing with these concerns. Students have completed their first major assignment, a Book Review in Indigenous Learning. Weekly seminars take place on Fridays in English and students have written their Math mid-term and two science tests. Overall, attendance as a group has been in the 70% range with a typical day having 10/14 students in class.

The students are busy with assignments, deadlines and becoming accustomed to life on campus.

THE NATIVE NURSES ENTRY PROGRAM REPORT TO THE ABORIGINAL MANAGEMENT COUNCIL

November 25, 2010

This report is intended to update the Council members on the activities of the NNEP since the last report presented at the October 25, 2010 AMC meeting.

Student Progress

There is currently 22 students enrolled in the NNEP. The NNEP students have all been in for continuous checkpoints with the Counsellor/Liaison and the Manager as well. The 4 returning students currently academic probation continue to come in weekly to bi-weekly for checkpoints.

The NNEP Graduation Ceremony last year's NNEP 24th Intake was held on October 21, 2010. There were 6 of the 9 students in attendance. Each of the students was presented with a certificate of completion and a small gift on behalf of the program. (The NNEP staff had approached several of the Education Authorities for any donations of their promotional items i.e. Binders, USB ports, pens, pencils, water bottles, hats, mugs, etc)

Program Update

Elder, Gerry Martin has conducted an educational session for the students on October 26, 2010 on the "Medicine Wheel Teachings". This was open to all students & faculty, etc. to attend on campus. Gerry also has provided on site one-on-one sessions with the NNEP students on October 28, 2010 in the Aboriginal Initiatives Student Lounge.

The second monthly Instructor's Meeting took place on October 30, 2010 to discuss the NNEP Student's progress and to share any best practices in preparations for conducting the checkpoints. The next Instructor's Meeting will take place on December 10, 2010. The Instructor's Meetings are very beneficial to both NNEP staff as well as for NNEP Instructors, it gives the Manager and Counsellor/Liaison Worker a real picture of how each of the students are progressing.

The NNEP Manager is teaching the N1110 Communication Course this term with eighteen of the NNEP students. The NNEP Manager attends the Chemistry and Biology classes along with the students to assist as much as possible tutoring when required. Some of the common issues brought forth from the student checkpoints are as follows: issues of alcohol abuse in families, stress related to assignments and time management, health issues, and racism throughout the city. Each of the courses has had assignments and tests so far which have given the NNEP Manager an idea of the progress of the students to date. So far several students in each of the courses are struggling academically. Each of these students are accessing the use of the tutors in the Learning Assistance Center, Aboriginal Initiatives Peer Mentors, and the several of the Instructor's have offered extra assistance to these students as well.

Orillia Campus report for the Aboriginal Management Council (Nov. 15, 2010)

At the request of the Aboriginal Management Council, the Orillia campus will now be presenting reports to the Council. The following report is an update on recent initiatives.

The Elders-in-Residence program at Orillia, which was developed in conjunction with the Office of Aboriginal Initiatives during the spring of 2010, was launched this fall. Two elders willing to participate in the program have been identified and the first visits are now taking place. Posters have been displayed and Student Affairs is preparing online promotion to students.

Faculty and Staff at the Orillia campus working in conjunction with the Office of Aboriginal Initiatives are now planning, as a follow up to last year's outreach event to directors of education in neighbouring First Nations communities, for an Aboriginal Stakeholders Conference, to be held February 16 and 17, 2011. Student Affairs is assisting in setting up a panel discussion with members of the various Aboriginal communities

In addition to its current course offerings with an Aboriginal focus in the Honours Bachelor of Arts and Science, the Bachelor of Education and the Honours Bachelor of Education, the Orillia campus is planning to offer an Ojibwe language course in Orillia this summer.

Faculty at the Orillia campus are currently designing two new degree programs in Media Studies and Criminology, and the advisory committees overseeing the development of these programs is exploring the inclusion of Aboriginal content in the curriculum.

The Campus Dean has recommended to the Advisor's Committee that it might be helpful to provide members of the Aboriginal Management Council with a comprehensive overview of the University's plans for the development of the Orillia campus, and is seeking direction from the AMC concerning the scheduling of this presentation in the new year.



Strategic Planning

The Aboriginal Management Council has formed a sub-committee that will assist with areas related to the Strategic Plan and report back to the AMC on Lakehead University's initiatives related to that Plan particularly those related to non-academic matters such as student satisfaction, support services, accessibility, research, and community involvement.

The Joint SAC/AMC subcommittee of the Senate Academic Committee will become involved in the Aboriginal academic matters related to the Strategic Plan.

NAN Treaty 9 and Treaty 5 Symposium

The Office of Aboriginal Initiatives is planning a partner symposium with NAN and Indian and Northern Affairs to host a two day Treaty 9 and Treaty 5 Symposium at Lakehead University on February 23rd & 24th. The goal of the Symposium is to educate people on the Treaties.

Aboriginal Research Facilitator

The Office of Aboriginal Initiatives has created a position to hire on contract an Aboriginal research Facilitator. The Aboriginal Research Facilitator will be responsible for:

- Establishing and maintaining a liaison role with Aboriginal community in northwestern Ontario and the Orillia catchment area to assist with the identification of community research needs and to link communities with Lakehead researchers and vice versa.
- Promoting the value of pure and applied research in meeting the challenges faced by the Aboriginal communities the University serves.
- Encouraging the development and growth of Aboriginal research at the University
- Collaborating with individuals/groups across campus to explore opportunities for the advancement of research and scholarly work.

The position has been advertised and will begin as soon as a suitable candidate is found.
