5.1 Lakehead University Native Student Association (LUNSA) Term Appointments to O-AGC

The report on "The Status of Indigenous Initiatives at Lakehead University 2015" was distributed in advance with the meeting materials.

MOVED (N. Bouchard/T. Pile) to accept the report on "The Status of Indigenous Initiatives at Lakehead University 2015" and refer the report to the President for a response. CARRIED Members discussed the possibility of making the report on "The Status of Indigenous Initiatives at Lakehead University 2015" public. It was noted that the Board of Governors Learning & Research Committee would benefit from having access to the report.

- 7.1 Ministry of Training, College and Universities, Targeted Initiatives Fund (TIF) Project Proposal 2016-2018
  - 7.1.1 Coordinated Learning Access Network (CLAN)

Dr. Cynthia Wesley-Esquimaux reported that CLAN will be hiring five students from external organizations to recruit users to the CLAN/MAGNET website. Ongoing recruitment efforts across Northern communities will continue with support from the Lakehead University Student Union (LUSU), YES Employment Services, Matawa First Nations, and Confederation College.

29 universities, over 65,000 students, and 4,500 employers are currently on the MAGNET website.

- 7.1.2 Aboriginal Mentorship Program (AMP)
  - Dr. C. Wesley-Esquimaux announced that AMP is in the process of hiring an Assistant Coordinator.

- A recommendation to the O-AGC that new position of Acting Director of Student Success become a member of the O-AGC Advisors Committee.
